#### 4. Chair's Report

Chair Dunn welcomed the members to the March meeting of the Regional Transit Committee. The Chair commented on: 1) Our legislation under the King County Charter, regional committees generally have 120 days to consider legislation. In this case, approval from the Committee in June would allow Council action in July, primarily because the policy decisions will have a direct impact on the 2012-2013 biennial transit budget, and 2) The Chair reminded the members of the need for workshops and proposed that the committee hold two workshops on March 30 and April 7 outside the Courthouse.

#### 5. General Manager's Report

Kevin Desmond, General Manager, Transit Division reported on: 1) Gas price increases and how they hurting Metro's budget. 2) New forecast Sales tax for the County, which has a negative effect on the transit financial plan. 3) Bill 5457 will allow only King County a \$20 congestion fee, if adopted the bill would provide an option to address the budget problem, and 4) An informal labor union committee formed to discuss the scheduling deficiency issues expressed by the transit operators' testimony.
