Ms. Patterson reported on the Sound Transit Board, indicating that CEO Joni Earl, spoke about upcoming changes in the federal Department of Transportation. The Board received an update regarding the Northgate link extension project, which is scheduled to open for service in 2021. The Board also received updates on multiple projects that have been completed. The Board took action on eight consent items and five business items. Ms. Patterson also reported that she and Councilmember McDermott attended the Sound Transit groundbreaking event for the permanent Sounder station in Tukwila. She also commented on Sound Transit making connection with Metro's Rapid F Line.

Mr. Phillilps reported on the Cedar River Council, indicating that the members met outside of North Bend, at the upper watershed. The Council discussed membership and recovery aspects. The Board heard a report on bull trout, which is a listed species on the Endangered Species Act. Mr. Phillips invited members to the Ballard locks to see the return of the sockeye. The next meeting will include a field trip along the Cedar River.

Mr. Dembowski also made comments about the sockeye season.

Ms. Hague reported on the Eastside Rail Advisory Committee. She indicated the group works on a combined long term vision. The group heard a presentation from representatives from Minneapolis, Minnesota on the multiple uses in the multiple counties in that metropolitan area. The committee also heard the vision from Snohomish County. Later in the month there will be a presentation given at an open house; and she informed the Council that Committee of the Whole will soon focus on the Eastside Rail Corridor issues.

Other Business

Mr. von Reichbauer requested a moment of silence for the recent Prescott, Arizona firefighters who recently lost their lives protecting the rest of the community.
