AN ORDINANCE relating to department of judicial administration fees; and

adding a new section to K.C.C. chapter 4.83.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> A. Section 2 of this ordinance authorizes the department of judicial administration to assess a fee for preparing and providing new case and new judgment reports.

B. The fee in section 3 of this ordinance is assessed as authorized under section 2 of this ordinance.

SECTION 2. The department of judicial administration is hereby authorized to assess a fee for preparing and providing new case and new judgment reports.

<u>NEW SECTION. SECTION 3.</u> There is hereby added to K.C.C. chapter 4.83 a new section to read as follows:

A. The department of judicial administration is hereby authorized to assess and collect a fee for preparing and providing a report of new cases filed in superior court or new judgments filed in superior court.

B. The fee shall be five dollars per report.

C. The department of judicial administration shall establish a procedure for the collection of this fee.

SECTION 4. This ordinance takes effect January 1, 2011.
