1 AN ORDINANCE making supplemental appropriations of

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 SECTION 1. Ordinance 16717, Section 138, as amended, is hereby amended by
 8 adding thereto and inserting therein the following:

9 PUBLIC TRANSPORTATION CAPITAL IMPROVEMENT PROGRAM -

10 From the public transportation construction fund, for a project appropriation involving
 11 the Burien Transit Oriented Development Garage project identified in Attachment A to
 12 this ordinance, there is hereby appropriated to:

15 ER1 EXPENDITURE RESTRICTION:

16 Of this 2010 appropriation for CIP Project 300808, South Regional Maintenance
 17 Facility, no funds shall be expended until an ordinance is enacted authorizing amendment
 18 of the Summit Pit Purchase and Sale Agreement to include but not be limited to time
 19 extension of deadlines in the Summit Pit Purchase and Sale Agreement.

20 ER2 EXPENDITURE RESTRICTION:
21 Of this amount, \$14,730,000 may only be expended or obligated after Sound
22 Transit and King County enter into a binding agreement authorizing payment by Sound
23 Transit to King County of \$14,730,000 for the project, and \$6,666,066 may only be
24 expended or obligated after the Federal Transit Administration has approved the terms
25 and conditions of the Ground Lease and the Lease Agreement (With Option to Purchase)
26 for the project, which was authorized under Ordinance _____ (Proposed Ordinance
27 2009-0546).

28 SECTION 2. Attachment A to this ordinance hereby amends Attachment H to

29 Ordinance 16717, as amended, by adding the Burien TOD Garage project to Ordinance
30 16717.




