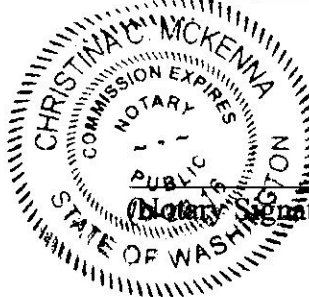

NOTICE IS HEREBY GIVEN, that the Metropolitan King County Council will consider Proposed Motion 2014-0148, identifying a project to be funded under Public Law 106-393, Title III, of the Secure Rural Schools and Self-Determination Act of 2000, as amended, and allocating to that project the funds to be received from the federal government for federal fiscal year 2013 on June 9, 2014. Comments from the public on the motion will be accepted until June 4, 2014.

### SUMMARY

Proposed Motion 2014-0148 proposes to use 2013 Title III funding to continue the Firewise Forests Initiative in the Forestry Program of the Water and Land Resources Division of the Department of Natural Resources and Parks, which will assist rural communities to develop Community Wildfire Protection Plans and promote the use of practices that reduce the risk of wildfire.
