	Proposed No. 2012-0258.2 Sponsors Phillips
1	AN ORDINANCE relating to improvements in parks,
2	requiring approval by ordinance for the construction or
3	installation by private persons of certain improvements to
4	county parks.
5	STATEMENT OF FACTS:
6	1. King County encourages collaborative development of parks facilities
7	with private not-for-profit organizations and others. Severe funding
8	constraints have limited the availability of public funds for parks
9	development, particularly athletic fields.
10	2. It is important that the county's policy-makers have the opportunity to
11	determine the appropriateness of specific major improvements to parks
12	before they are constructed, as well as the terms and conditions under
13	which they are provided.
14	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
15	NEW SECTION. SECTION 1. A new section is added to K.C.C. chapter 7.08 to
16	read as follows:

17	No improvement or construction in any county park with a fair market value in
18	excess of fifty thousand dollars shall be made unless authorized in advance by ordinance.
19	SECTION 2. A. The parks and recreation division of the department of natural
20	resources and parks shall prepare a report setting forth recommendations for
21	modifications to policies, procedures and code that implement the community
22	partnerships and grant program, use agreements and permits for effectiveness and
23	transparency. The report should demonstrate how the proposed modifications
24	sufficiently notify the council before any improvement or construction with a fair market
25	value of fifty thousand dollars or more and funded by private contributions in a county
26	park is initiated.
27	B. The report required by this section shall be transmitted to the council by
28	January 15, 2013 with an ordinance, which acknowledges receipt of the report and
29	repeals this ordinance. The report must be filed in the form of a paper original and an
30	electronic copy with the clerk of the council, who shall retain the original and provide an
31	electronic copy to all councilmembers and to the lead staff for the transportation,
