I am writing to let you know about a public hearing on a proposed name change for your street. As you may know, a petition has been presented to the Metropolitan King County Council to change the name of a portion of SE 300th Street to SE Falcon Way. Because this street is located in unincorporated King County, the County Council is responsible for deciding whether or not to change the street name. If the County Council approves the name change, the street address of your property on SE 300th Street will be changed.
