NOTICE IS HEREBY GIVEN, that a public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001 on the 14th day of November, 2023, at 1:30 p.m. to receive public testimony related to Proposed Ordinance 2023-0202. Proposed Ordinance 2023-0202 would establish interim 15-month zoning regulations on residentially zoned land in the Fall City Rural Town, requiring a minimum 10,000 square foot lot size, 10-foot interior setbacks, and 20-foot street setbacks.
