The medical marijuana moratorium extension would renew an existing moratorium for an additional six months. The moratorium would prohibit permitting or operation of any medical marijuana collective gardens or dispensaries, in unincorporated King County, for six months, starting June 16, 2015.

The original moratorium was adopted by Ordinance 17726, and the first renewal was adopted by Ordinance 17940.
