1 AN ORDINANCE authorizing the King County executive  
2 to enter into interlocal cooperation agreements and  
3 amendments to interlocal cooperation agreements with the  
4 cities of Auburn, Kent, Lake Forest Park, Seattle and  
5 Shoreline for the disbursement of conservation futures tax  
6 levy funds appropriated under Ordinance 15652, as  
7 amended by Ordinances 15815 and 15898.

STATEMENT OF FACTS:

10

1. Conservation futures tax levy funds are collected throughout King  
11 County as a dedicated portion of the property tax and are, by statute,  
12 available only for the acquisition of open space and resource lands.

2. Ordinance 14714 established procedures for the annual allocation of  
14 conservation futures tax levy funds, which directs the conservation futures  
15 citizens committee to make funding recommendations to the King County  
16 executive to consider for inclusion in the annual budget ordinance.

3. The executive has transmitted and the King County council has

appropriated 2007 conservation futures funds by Ordinance 15815 and

19 Ordinance 15898 to the open space projects listed and described in  
20 Attachment B to this ordinance.

21 4. The county desires to disburse conservation futures funds to the city of  
22 Seattle and suburban cities, and must do so by amending existing, or  
23 executing new, interlocal agreements with these jurisdictions.

24 5. The county and the cities are authorized to enter into an interlocal  
25 agreement pursuant to chapter 39.34 RCW, the Interlocal Cooperation  
26 Act.

27 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

28 SECTION 1. The King County executive is hereby authorized to enter into and  
29 execute interlocal cooperation agreements or amendments to interlocal cooperation  
30 agreements, containing language substantially similar to that attached to this ordinance,

31 necessary for the disbursement of conservation futures tax levy funds appropriated under  
32 Ordinance 15815 and Ordinance 15898.





**AMENDMENT TO THE CONSERVATION FUTURES  
INTERLOCAL COOPERATION AGREEMENT  
BETWEEN KING COUNTY AND THE CITY OF \_\_\_\_\_  
FOR OPEN SPACE ACQUISITION PROJECTS**

**Preamble**

The King County Council, through Ordinance 9128, has established a Conservation Futures Levy Fund and appropriated proceeds to King County, the City of Seattle and certain suburban cities. This amendment is entered into to provide for the allocation of additional funds made available for open space acquisition.

THIS AMENDMENT is entered into between the CITY OF \_\_\_\_\_ and KING COUNTY, and amends and attaches to and is part thereof of the existing Interlocal Cooperation Agreement entered into between the parties on the \_\_\_\_\_ day of (Month), (year), as previously amended.

The parties agree to the following amendments:

**Amendment 1: Article 1. Recitals**

A paragraph is hereby added to the Recitals Section to provide for a Conservation Futures Levy Fund allocation for the \_\_\_\_\_ Acquisition, and hereafter reads:

Subject to the terms of this agreement, the County will provide Conservation Futures Levy Funds in the amounts shown in Attachments A through \_ to be used for the Projects listed in Attachments A through \_\_\_. The City may request

additional funds; however, the County has no obligation to provide funds to the City for the Projects in excess of the total amounts shown in Attachments A through \_\_\_\_\_. The County assumes no obligation for the future support of the Projects described herein except as expressly set forth in this agreement.

**AMENDMENT 4: Attachment \_\_\_\_\_**

The attachments to the interlocal agreement are hereby amended by adding Attachment \_\_\_\_\_, which is hereby attached to the interlocal agreement, incorporated therein and made a part thereof.

In all other respects, the terms, conditions, duties and obligations of both parties shall remain the same as agreed to in the Interlocal Cooperation Agreement as previously amended.

This document shall be attached to the existing Interlocal Cooperation Agreement.

## 2007 Conservation Futures (CFT) Project Descriptions

### Seattle CFT Projects:

#### **315420 West Capitol Hill Urban Center Park**

Located on Summit Avenue East at East John Street, and Olive Way, this proposed .22 acre open space is located in the high-density neighborhood of West Capitol Hill. The site is currently a parking lot that will be redeveloped and converted into a neighborhood greenspace.

2007: \$500,000 in Conservation Futures Funds is allocated to this project. (Ordinance 15815)

2007: \$100,000 in Conservation Futures Funds is allocated to this project. (Ordinance 15898)

### Suburban City CFT Projects:

#### **315711 Auburn CFL (Auburn Environmental Park)**

##### Scope Change:

2007: the project scope is expanded to include property adjacent to the park east of Western Avenue that will allow for a connection to Clay Street and improved access to the park.

#### **315725 Kent: Clark Lake**

##### Scope Change:

2007: CFT funds that were allocated to specific parcels in the Clark Lake project in the years 2003, 2004, and 2005 may be expended for the purchase any of the other approved parcels from those years, should there be a funding shortfall for those parcels.

#### **315725 Kent: Mill Creek**

##### Scope Change:

2007: \$15,000 in CFT funds that were allocated in the 2006 budget to purchase a two acre parcel located west of Mill Creek are authorized to be expended on the 14-acre Mill Creek/ Green River Confluence parcel that was funded in the 2005 budget, and located east of the Creek.

#### **315757 KNT - Koch Farmland**

This project consists of the acquisition of development rights of up to 6.16 acres of land between the Green River and the West Valley Highway, near the confluence of Mill Creek and the Green River. The site is currently used for farming, though it is not in the Agricultural Production District. Restoration of Green River riparian habitat on the property for salmonid and other aquatic species is allowable.

2007: \$25,000 in Conservation Futures Funds is allocated to this project. (Ordinance 15898)

**315759 LFP - Grace Cole Nature Park Greenway**

This project is a multiple-parcel greenway area on 28th Avenue Northeast in Lake Forest Park. The first priority for acquisition is a 1.5 acre wooded property containing riparian headwaters of Brookside and McAleer Creek, the later of which is a documented spawning area for Coho and Sockeye salmon.

2007: \$500,000 in Conservation Futures Funds is allocated to this project. (Ordinance 15898)

**315762 SHO - North Hamlin Park Addition**

This project consists of the acquisition of an 8.3-acre property in the City of Shoreline that contains woodland and open field habitat, bounded to the north by 168th Street Northeast and to the south by 73-acre Hamlin Park.

2007: \$300,000 in Conservation Futures Funds is allocated to this project. (Ordinance 15898)
