B. HISTORY AND OVERVIEW

R.C.W. 36.87 establishes the right of property owners to petition a county legislative body for the vacation of road rights-of-way. K.C.C. 14.40 establishes King County policies and procedures for accomplishing same.

The petition was filed with the Clerk of the King County Council on March 17, 2022, by Patricia Barajas and Cuauhtemoc Barajas Reina. Michael and Kyong O. Hong and Zoe and Derek Anderson later jointed the petition for the vacation of a portion of the platted street and alley in the Plat of Stillwater in the Carnation area of unincorporated King County.

The subject right-of-way was dedicated to King County in the Plat of Stillwater in May 1910. See Exhibit 9.

The subject portion of right-of-way qualifies as unopen and unmaintained county road right-of-way.

Prior to the public hearing for this road vacation petition, Michael and Kyon Hong sold parcel 801610-0040 to KK & S Corporation. Kyoung Kim is the President of KK & S Corporation. Kyoung Kim has indicated that he wishes to step in as Petitioner and new owner of the Parcel and continue with the road vacation.

C. NOTICE

Notice of this hearing was posted at the approximate ends of the proposed vacation area on September 18, 2024, see Exhibit 22, and published in accordance with requirements of RCW 36.87.060.

A copy of the County Road Engineer's Report and the Notice of hearing were sent to an abutting property owner, Oscar Romero Santos and Teah Romeral Bouton on September 23, 2024.

D. REVIEWING AGENCIES AND COMMENTS

The King County Department of Local Services, Road Services Division ("Roads") solicited comments from agencies within King County and utilities serving the area regarding the impacts of vacating the subject area. The responses received are listed below. No utility or agency identified infrastructure within the subject right-of-way or requested an easement over the vacation area.

Roads did not receive responses from Comcast, King County Fire District #10, and the following King County agencies: Executive Services, Division of Real Estate Services and Historical Preservation; Department of Natural Resources and Parks, Open Space Division; Metro Transit: and the Department of Local Services Road Services Division Maintenance Section and Archeologist. A copy of the Notice is included as Exhibit 12.

E. COMPENSATION

Utilizing the model prepared by King County Office of Performance, Strategy and Budget (PSB), Roads solicited from the Assessor's Office a determination of value for the vacation area that will attach to the property owned by Petitioners. See Exhibit 13.

If the petition is approved, parcel 042507-9008 owned by Patricia Barajas and Cuauhtemoc Barajas Reina, will receive approximately 8,308 square feet. The Assessor's Office determined that adding approximately 8308 square feet to the parcel would result in a \$5,000 change in value. The valuation as applied to the compensation model prepared by the County Office of Performance Strategy and Budget (PSB), with offsets for management and maintenance costs and future expected property tax, results in a charge of compensation to Petitioners Patricia Barajas and Cuauhtemoc Barajas Reina in the amount of \$730 should the vacation be approved. See Exhibit 14.

If the petition is approved, parcel 801610-0040 owned by KK & S Corporation, will receive approximately 8,243 square feet. The Assessor's Office determined that adding approximately 8,243 square feet to the parcel would result in a change in value totaling \$8,243. The parcel is valued at one dollar per square foot. The valuation as applied to the PSB compensation model, with offsets for management and maintenance costs and future expected property tax, results in a charge of compensation to Petitioner KK & S Corporation in the amount of \$3,913 should the vacation be approved. See Exhibit 16.

Parcel 801610-0030, owned by Petitioners Zoe and Derek Anderson, will receive approximately 1,354 square feet if the petition is approved. The Assessor's Office determined that adding approximately 1,354 square feet to the parcel would result in a \$5,000 change in value. The valuation as applied to the PSB compensation model, with offsets for management and maintenance costs and future expected property tax, results in a charge of compensation to Petitioners Zoe and Derek Anderson in the amount of \$730 should the vacation be approved. See Exhibit 15.

F. COUNTY ROAD ENGINEER RECOMMENDATION

The County Road Engineer has determined that the subject portion of right-of-way is useless to the county transportation system and that petition V-2754 should be approved with the condition of payment of compensation in accordance with the PSB model.
