Salmon Recovery

Chair Constantine made opening remarks. He noted that an article reported in The Seattle Times on October 25, 2008 that seven orca whales, regular visitors to the Puget Sound, are feared dead as a result of the smaller population of chinook salmon was distributed to the members and audience.

Sandy Kilroy, Regional Services Section Manager, Water and Land Resources Division, briefed the committee with an overview on Salmon recovery efforts and answered questions from the members during the powerpoint presentation.

Elizabeth Walker, Councilmember, City of Duvall, and Vice Chair, Snoqualmie Watershed Forum; Dr. Don Davidson, Councilmember, City of Bellevue and Co-chair, Lake Washington/Cedar River/Sammamish Watershed Forum; and Joan McGilton, Mayor, City of Burien and Co-chair, Green/Duwamish and Central Puget Sound Watershed Forum, discussed salmon recovery and implementation challenges and answered questions from the members during the powerpoint

presentation.

Jennifer Giambattista, Council Staff, briefed the committee on the 2009 King County Budget and its effect on salmon recovery. She answered questions from the members. Sandy Kilroy answered questions from the members.

David Dicks, Executive Director, Puget Sound Partnership, discussed the role of the Puget Sound Partnership in salmon recovery and answered questions from the members. He noted that salmon recovery is linked to the clean-up of Puget Sound. He answered questions from the members. Requested that the Council maintain funding for the WRIAs.
