1 AN ORDINANCE establishing the crisis care centers fund;
2 and adding a new section to K.C.C. chapter 4A.200.

3 **STATEMENT OF FACTS:**

4 1. In January 2023, Ordinance 19572 placed a nine-year crisis care
5 centers levy on the April 2023 special election ballot to establish and
6 operate a regional network of crisis care centers in King County, to restore
7 mental health residential treatment bed capacity, and to increase the
8 sustainability and representativeness of the behavioral health workforce in
9 King County.

10 2. In April 2023, King County voters approved Proposition No. 1 to
11 authorize the crisis care centers levy from 2024 through 2032.

12 3. Ordinance 19572, Section 3, requires proceeds from the crisis care
13 centers levy to be deposited into the crisis care centers fund, or its
14 successor.

15 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

16 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 4A.200

17 a new section to read as follows:

18 A. There is hereby created the crisis care centers fund.

19 B. The fund shall be a first tier fund. It is a special revenue fund.

20 C. The director of the department of community and human services shall be the
21 manager of the fund.

22 D. The fund shall account for the proceeds of the property tax levy in excess of
23 the levy limitation contained in chapter 84.55 RCW that was approved in 2023 in
24 accordance with Ordinance 19572, and any successive levies, unless otherwise required

- 25 by ordinance. The levy proceeds are for the express purpose of paying eligible
26 expenditures as provided in Ordinance 19572 and any successive levy ordinances.


Ordinance 19704 was introduced on 10/17/2023 and passed by the Metropolitan King County Council on 11/28/2023, by the following vote:





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact King County-Department of 02:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at cipriano.dacanay@kingcounty.gov and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software
