1 **AMENDMENT TO PROPOSED ORDINANCE 2017-0175, VERSION 1**

2 On page 4, after line 58, insert

3 "SECTION 3. A. By November 30, 2020, the executive shall transmit a report on
4 regional animal services of King County program outcomes and financial sustainability
5 and a motion to acknowledge receipt of the report. The report shall include without
6 limitation:

7 1. A summary of regional animal services of King County program outcomes
8 regarding animal control field response, sheltering, and licensing services provided to
9 unincorporated areas of King County, disaggregated by ZIP Code, annually for the years
10 2017, 2018, 2019 and through August 31, 2020;

11 2. A summary of regional animal services of King County program outcomes
12 regarding animal control field response, sheltering, and licensing services provided to
13 contracting cities annually for the years 2017, 2018, 2019 and through August 31, 2020;

14 3. Analysis of county general fund support for the regional animal services of
15 King County program over time since 2013, including estimated financial support
16 biennially through the 2023-2024 biennium;

17 4. Analysis of the regional animal services of King County operating fund
18 balance over time since 2017, including estimated ending fund balance biennially through
19 the 2023-2024 biennium; and

20 5. The executive's recommendation whether to extend the 2018 regional animal
21 services interlocal agreement for a second five-year term as described in section 4 of the
22 interlocal agreement.

23 B. The executive shall file the report and a motion to acknowledge receipt of the
24 report no later than November 30, 2020, in the form of a paper original and an electronic
25 copy with the clerk of the council, who shall retain the original and provide an electronic
26 copy to all councilmembers, the council chief of staff and the lead staff for the
27 government accountability and oversight committee, or its successor.

28 C. If the council does not pass a motion acknowledging receipt of the report by
29 April 30, 2021, then, unless provided authority through an ordinance approved by council
30 to renew the 2018 regional animal services interlocal agreement for a second five-year
31 term, the executive or the executive's designee shall no later than June 30, 2021, give
32 notice to the other Contracting Parties, in accordance with sections 4.a. and d. of the
33 interlocal agreement, advising them of the county's intent to opt out of the automatic
34 renewal for a second five-year term and determination to terminate its participation in the
35 agreement at the end of the agreement's initial five-year term."

36 **EFFECT: Requires the Executive to transmit a Regional Animal Services of King**
37 **County program outcomes and financial sustainability report, and a motion to**
38 **acknowledge receipt of the report, to Council by November 30, 2020. Makes clear**
39 **that if Council does not pass a motion to acknowledge receipt of the report by April**
40 **30, 2021, then unless provided authority by a Council-approved ordinance to renew**
41 **the agreement for a second term, the Executive must, by June 30, 2021, give notice**
42 **to the other Contracting Parties of the County's intent not to participate in the**
43 **agreement beyond the initial term.**
