Dear Councilmember Perry:

This letter transmits a proposed Motion that would, if enacted, confirm my appointment of Sandra Valenciano as director of Public Health – Seattle & King County. I appointed Dr. Valenciano to serve as public health director starting March 30, 2026. My appointment of Dr. Valenciano's appointment was made in consultation with, and with consent from, City of Seattle Mayor Katie Wilson. A full set of confirmation documents will be submitted under separate cover.

Dr. Valenciano has been serving successfully as both acting director of Public Health – Seattle & King County and as King County's health officer since December 12, 2025. Prior to her acting appointment, she served as the King County health officer. In that role, she served as the department's primary medical expert, providing leadership on scientific and medical matters that shape department policy and practice, while fostering strong relationships with the healthcare community.

Dr. Valenciano is a board-certified physician in internal medicine and holds a master's degree in Public Health from Tulane University. Prior to arriving at Public Health – Seattle & King County, Dr. Valenciano served as medical director and district health director/chief executive officer for DeKalb Public Health where she oversaw all operations and delivery of public health services for over 780,000 residents in DeKalb County, Georgia.
