The purpose of this hearing is to consider adoption of Proposed Ordinance No. 2022-0385, which would update King County Code Title 27 pertaining to prescribing fees and fee collection for permitting and environmental review services provided by the department of local services' permitting division and road services division, and the department of natural resources and parks. The proposed ordinance is being reviewed concurrently with the proposed 2023-2024 King County Biennial Budget.

SUMMARY
Proposed Ordinance No. 2022-0385 would update King County Code Title 27 to amend requirements related to fee waivers; amend fees for permitting and environmental review services provided by the department of local services' permitting division and road services division, and the department of natural resources and parks; and add a surcharge of two and five tenths percent on certain fees.

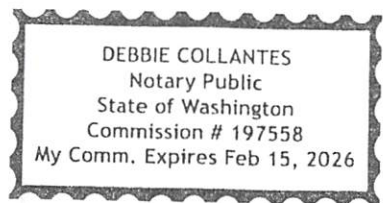
