The purpose of this public hearing was to consider adoption of Proposed Ordinance 2019-0413 (Ordinance 19146) an ordinance adopting 2020 amendments to the 2016 King County Comprehensive Plan (Comprehensive Plan), and as amended in 2017 and 2010. including the proposed adoption of the Skyway-West Hill Land Use Strategy as an amendment to, and element of, the Comprehensive Plan. The Council then adopted this Ordinance at the Friday, July 24, 2020 meeting.


