My name is Karen Morris, and I reside at 15788 NE 4th St. Bellevue Wa., across from a 4 time site of TC4.

I am here to speak to you this morning, even though I just found out that this issue was on the agenda last Friday.

This constitutes an unfortunate repeat of a serious flaw in the way input on this issue has traditionally been gathered. I am talking about the lack of timely and substantive input from the residents of the neighborhoods that these encampments have repeatedly located in and impacted.

We have direct knowledge of how well the existing regulations have worked to maintain commitments to neighbors, and in what specific ways they have not worked. Some of us have gathered a lot of pertinent documentation. And yet we have not had a chance to provide any of that information until now, even though King County Staff members have known how to contact some of us.

King County Staff, the Committee to End Homelessness and others have been involved in this process much earlier. A Checklist of Criteria dated 7-31-14 claims under “Interested Parties” that adequate collaboration has occurred with all those affected by the proposed regulation. I strongly disagree.

This is the 2nd report to the Committee of the Whole , and there has already been a “1st reading” at the September 29th County Council meeting.

If this process is meant to be fair and result in regulations that address all substantive concerns adequately for the next decade, this process flaw needs to change now. Council members and staff need to make outreach efforts and take the time to really listen to the suggestions of representatives of the affected neighbors and members of the public. And also look at the documentation that supports what we think is necessary to have included if these regulations are to be fair and effective in maintaining the public health and safety of all, and the commitments repeatedly made to these neighborhoods, but often not kept.

I spoke to you at the last meeting regarding my concerns about the process around re-enacting this ordinance. My concerns remain. I continue to have trouble getting information or even responses to specific questions from county officials. My input from that meeting has yet to show up on the county website. And I have not noticed any outreach being initiated to get the neighborhood input this process has been lacking so far. I am having trouble seeing how that essential neighborhood input can be effectively given and processed in the small amount of time left if the council follows its original possible schedule. I sincerely hope that you will not hurry to a vote next week. Instead please give your affected constituents more time to have some input.

I have been trying to contact neighborhood residents I know that have input to offer. I have also tried to get some of them to come to these last two meetings. But most of your constituents in affected neighborhoods have work or other commitments that preclude their attendance at daytime meetings on weekdays. Especially if its placement last on the agenda means it could take all morning. Those of us who are here either have flexible schedules, or are retired. I am working with some of the neighborhood residents to perhaps turn in comments by email or mail, so please allow a little time for that to happen. I have some documents for you today along with a cover letter. I and others will be addressing other issues in more comment to be sent in soon. We hope you will read it and consider it. If we had known about this process sooner, we would have provided our input much sooner. There are some improvements to this ordinance that would be very helpful to maintain commitments to everyone impacted. Some of the proposed changes and Amendments would move us in that direction, specifically Amendments 2, 3, 4 & 5. Others are more problematic and we will be trying to address that in future comments. Thank you for your attention to this matter.

maintained. The City of Sammamish in their recently enacted ordinance did just that, and King County should do it now by approving Amendment #5. To do otherwise is to ignore the public safety commitments made to neighbors and encampment residents alike. The encampments have had 10 years to develop procedures that work, and they have failed to do so.

I have also included reports about the drug use issues that exist in this encampment. There has always been a lot of anecdotal information about drug use in these encampments, and at times in the past police reports. But the reports about the systematic drug problem during the recent Sammamish stay of TC4 are current and telling. During the even more recent Bellevue stay of TC4 there was more anecdotal information that the drug problem continued, and then a drug overdose death occurred. I have included that police report here, not only because it shows an ongoing issue with drugs in the camp, but also because it illustrates another serious issue. That issue would be the lack of cooperation of encampment management with others, including police. A SHARE "fixer" was keeping residents from cooperating with the police who were trying to conduct a death investigation. Following that, encampment leaders also apparently did not choose to tell the liason person from their host what had really occurred, as he did not know when contacted by a neighbor with questions. This fits a pattern of willful blindness and covering things up to avoid dealing with them. That strategy makes it very hard to form good relationships with the neighbors. And there have been many other examples of this pattern over the years. Better regulations combined with verification and accountability might move things in the right direction. But it will probably also require a change in management of these encampments, or a change in their attitudes and methods.

We are providing police reports of major incidents that occurred during a few of the last stays of TC4, and during earlier stays in our neighborhood. They relate specifically to important issues that need to be addressed, and are not addressed with ordinances that are not specific enough, and lack any mechanism for verification and enforcement.

I have ordered these sections of reports chronologically.

Our jurisdiction has a requirement for warrant and sex offender checks. In the past they have only been done on new incoming residents, even though some residents have been there close to a decade. They were also done by KCSO instead of the local police, which defied jurisdictional logic and common sense. You can see from the final reports of early stays, and the emails between BPD and KCSO that this created a problem. Under that system, 50 % of the prospective residents who checked to have warrants were already gone by the time the Bellevue Police Department got notified and dispatched to the encampment. Even before the first Bellevue stay in 2005, the neighbors ask that BPD do the checks to avoid problems we had heard about from other jurisdictions. It also just seemed logical that was the best way to avoid problems. But TC4 and Scott Morrow always refused to do it, and it took us 9 years to convince our city officials to require it. When they did, during this last stay in 2014, the police were able to reach the encampment in time to prevent the warrant subjects from disappearing into our neighborhood 100% of the time. This is an example of how reasonable and logical the requests of neighbors have been. And also how effective what they request is in practice.

The 3-27-14 Memorandum from the Bellevue Police Department details the due diligence that they did, and the recommendations for improved regulations that came out of it. Conditions were improved not only by the above better warrant procedure, but also by a requirement allowing TC4 residents to make 911 calls without having to get their leadership's permission. The neighbors noticed many more responses by medical aide vehicles during this last stay, and we think that may be related. We are glad to see Amendment 2 addressing this issue, and hope it will be enacted.

The reports in that document from other jurisdictions contain some other serious recent problems, like a rape allegation in Sammamish that went unreported for 2 months, and a gun found in the TC4 restroom at the most recent Redmond stay.

But another problem with TC4 residents with warrants still remains. In 2008 we were able to get some unique data, due to TC4 turning in 51 of their residents names on affidavits in a court case. You can see from the chart covering that 2008 data, that out of 51 TC4 ongoing residents we were able to check, 3 had active outstanding warrants (6%). 10 residents (20%) also had committed 15 crimes *while resident* in the encampment. This goes straight to the issue of whether these encampments are willing to use screening and security procedures that maintain the commitments they have made to both the neighborhood residents and their own residents. They often promised us there would be no one in the camp with outstanding warrants. In fact, they claimed at one of our meetings that "no one with warrants will even show up, because the word is out on the street that we don't allow people with warrants" Yet not only did people with warrants continue to show up, but they had no effective procedure to deal with the warrants received by ongoing residents. The problem continues, as demonstrated by 2 of the recent BPD reports where a TC4 resident attracted police attention for another reason, and then turned out to have active outstanding warrants when their names were run. One of these individuals was the camp's "Bookkeeper", and had shown up with 2 outstanding felony warrants in Sammamish a couple of months before. And yet she was not only back in the encampment, she was back in her position of power. Since those 2 warrants only came to light by chance, it is hard to guesstimate how many more there might be. *What this makes apparent is that new ordinance requirements and procedures are necessary if the commitments the encampments make are to be*

Investigation

On 5/30/14 at approximately 2317hrs, I was on routine patrol heading northbound on 156th Ave NE approaching NE 8th Street when I looked to the east behind a closed 76 gas station located at 15615 NE 8th Street in Bellevue.

In the darkness of the closed business, I saw two figures heading towards the sidewalk after apparently being behind the business. I then pulled into the gas station to ascertain why the two were behind the closed business at this hour. The two subjects, a male and female saw me pull over and started cursing.

I then called out the contact on police radio and contacted the two. The two were verbally hostile and basically stated that they were looking at items in the donation bin behind the business. The two also stated that they were being harassed and that they are new to the area and live at Tent City four. The female stated she helps run Tent City four and complained about the city of Bellevue and about the police department. The female stated that the city did not like TC four and had forced the camp to put unnecessary rules in place.

At this point, I asked the two subjects for their identities while Officer Cufley arrived as back up and as Corporal Buck looked around the closed business to ascertain what the two might have been doing.

The male identified himself as Curtis A. Klatt 2/14/1969 out of Montana. The female verbally identified herself as Brandi P. Shaw 1/4/1974 and stated she had no ID on her person. Klatt came back clear out of Montana while Shaw came back with no computer record found. I asked Brandie again for her information and she now changed her middle name to L from P and stated she wasn't being serious before. Another records check was completed. Again no computer record was found. Eventually, I tried her maiden name of Osborne and completed another records check. This time the records check revealed that Osborne had a Felony Burglary warrant out for her arrest from KCSO for \$15,000.00.

Upon hearing the warrant information, I confirmed her physicals and asked radio to confirm the warrant. The warrant was confirmed a short time later. At this point, I arrested Brandie L. Osborne for her felony warrant. She was placed in handcuffs and the cuffs were double locked and checked for tightness. Upon searching Osborne incident to arrest, I located her Washington State ID card in her wallet.

Also upon searching Osborne, I located a small flashlight, a marijuana drug pipe that contained a small amount of marijuana inside.

Osborne was then handed over to Officer Cufley for transport. Corporal Buck was unable to determine what the two were doing behind the closed business.

Narrative:

Bail amount \$1,000 Cash Only

Osborne was taken into custody without incident and she was positively identified by her expired driver's license.

I confirmed the warrants through DATA and Deputy Hawley completed a Superform.

Brandi L. Osborne was booked into the KCSO Jail on the warrants only.

Towle returned to TC4.

CASE REPORT**NARRATIVE**

At about 1745 hours/8-13-14, I was in my marked patrol vehicle in front of Hillaire Park when I heard the sounds of two people yelling. I exited my patrol vehicle and saw five people around a picnic table in the park and a black female who I knew as "Tina" (later identified verbally as Tina L. Head) standing about 15' away from the group. A male at the table who was later identified via Maine ID card as Andre J Thibault (DOB: 1-5-68) was pointing at Tina and saying that he "was just threatened by her." Thibault was standing up and appeared to be upset. I walked up to the area where Tina was standing and she said: "I just came over here to ask him (Thibault) why he was talking shit about me." Tina then turned around and began walking south through the park. When she was about 40' away, Thibault yelled at Tina: "Next time I see you I'm going to kick your ass!" Tina did not respond, and continued walking away. I was about 6' away from him when he said that, and told Thibault to calm down. Thibault sat down, and he told me the following information.

Thibault said that he was sitting with the other four subjects at the picnic table when Tina approached him and began yelling at him, saying "You better not come to Seattle." Thibault added that Tina swore at him and used "homophobic" terms. He said that he felt threatened by Tina's statement, but did not want Tina arrested. He said he wanted the police to document the circumstances, and initially wanted the four subjects at the table to provide witness statements.

I asked Thibault why he told Tina that he was going to kick her ass the next time he saw her, and an unknown female in the group asked me: "What is he supposed to do if he felt threatened?" I explained to the female and Thibault that he could potentially be summonsed or arrested for harassment if Tina had felt threatened, and added that they could have reported it to me in the parking lot. A second female who identified herself as "Michelle" said that she saw the whole incident and thought that it wasn't fair that I was only focusing on the threat made by Thibault at the end. I explained to her that I would be taking a case report documenting the circumstances and that I would take a statement from anyone who wanted to provide me with one. I explained to Thibault that I would be issuing trespass notices to him and Tina, and that I would be contacting her at Tent City 4 after I finish taking statements from the group. Thibault was upset that he was getting trespassed and said that he would be taking the issue to court. I explained that I was issuing a trespass notice, and that there would not be court involvement unless he returned to the park. Thibault was upset and told the others in the group not to provide a statement. I explained to the group that it was up to each of them to decide whether they wanted to provide a statement or not, and initially only Michelle wanted to provide one. I asked her what she saw

and she began explaining the circumstances to me and then stopped shortly afterward to ask me why I wasn't writing anything down. I explained to her that I would first listen to her explain the story, then write the information down after she was done. Michelle then changed her mind and said, "forget it, I'll just have my lawyer write the statement," and asked for my name. I provided my name to her and issued the trespass notice to Thibault, explaining that it prohibited him from being on the Hillaire park property for one year. Thibault took his copy and left the area.

I drove to Tent City 4 and spoke with Tina. She said that she had heard from other TC4 members that Thibault was talking negatively about her. She said that Thibault had been recently kicked out of TC4 and said she wanted to confront him and ask him why he was talking about her. She said she went to the park and that after confronting him, they began to yell at each other. She said that she never directly threatened him, but admitted to saying something similar to "I'll see you on the street." She said that she was not threatened by Thibault yelling that he was going to kick her ass, and said she did not want to pursue a case against him. I issued Tina a trespass notice for the park and she said she understood to stay away from there for a year. I asked her if anyone at the table was at TC4, and she said "Aaron" was there. I met with a male who verbally identified himself as Aaron Ervin, and I remembered seeing him at the table in the park. Aaron agreed to provide me with a statement and told me the following information.

Ervin said that at about 1745 hours, he saw Tina walking up to the table where they were sitting. Ervin said that Tina had heard Thibault "was talking shit" about her, and she wanted to call him on it. Ervin said that he was sitting at the table with Thibault, Julia, Michelle, and an unknown male when Tina approached Thibault and said "why you talking shit?" Ervin said that Thibault initially denied it, but eventually said that Tina owed him money. Tina responded "Don't be talking shit," and Thibault replied "get the fuck out of here." Ervin said that Tina responded: "I'll see you on the street," and that Thibault responded "I'll kick your ass!" Tina replied: "Come on!" Ervin said that Thibault stood up and that Tina walked away. Ervin said that when they saw me walking towards them, Michelle said "shhhh." Ervin said that he heard Thibault yell "Next time I see you I'll kick your ass" to Tina as she walked away, and that he heard me ask everyone in the group if they wanted to provide a statement and that no one wanted to.

Checks with Norcom revealed that Thibault was clear and a respondent in an order. They also revealed that Tina had an unconfirmed misdemeanor warrant out of Renton for theft 3 (AOB: \$643). I contacted Tina with ofc. Cuffley at TC4,

and the warrant was confirmed. I told Tina she was under arrest for the warrant and handcuffed her, checking both sides before double locking them. I advised Tina that she had a right to legal counsel and said she would see a copy of her warrant at the jail. She said she understood, and Ofc. Cuffley took custody of her and transported her to a warrant meet with Renton PD.

Investigation:

On 07/01/14 at approximately 2310 hours, I was dispatched to Tent City Four located at 15727 NE 4th ST to assist AID with a CPR patient that was not responding.

Upon arrival I was brought back to "tent 15" and there were multiple AID units administering CPR to a male on the ground in front of the tent. Firefighters Lewis and Archer informed me that they were first on scene. They were told by the people in the neighboring tents that they had heard something from inside the tent then contacted the front desk, also that the male had a seizure a few days prior. The firefighters located the male on the floor of the tent and he had a "weak pulse." They pulled him out of the tent and placed him on the ground directly in front of the tent and started to perform CPR. When they checked for a pulse again they were unable to locate one. Additional AID units arrived on scene and they were relieved from CPR.

At approximately 2321 hours, AID units pronounced the male deceased. The units on scene prior to my arrival did not notice any weapons, blood, or anything that raised suspicion at the scene or on the body. They visually noticed needles inside the tent. Due to the high volume of AID units I was unable to inspect the tent when I first arrived on scene but the exterior of the tent did not show any signs of foul play. Once the AID units cleared I visually inspected the body and did not notice any obvious signs of foul play or any inside the tent. I did notice what appeared to be needle marks on his inside right elbow and needles inside the tent.

Lt Popochock arrived on scene and I informed him of the situation. Lt Popochock remained at scene and I went to the front desk area. While I was at the front desk a male named "Marvin" was also there. He informed the deceased male's name was "James Kendal". I asked him where the witnesses that were in the neighboring tents were and he initially ignored me. I pointed to two people partially blocked behind a wood divider and asked if they were the witnesses. He said they were filling out paperwork for the camp and that I could not talk to them. I asked him what their names were and he refused to tell me. I informed him that this was an open police investigation and whenever they were done with the paperwork for the camp that I would have to speak to them about what they witnessed. Marvin informed me that they did not have to talk with me and that they would not.

Officer Johnson arrived on scene and I informed her about Marvin being uncooperative and denying access to the witnesses. Marvin approached us and stood squared with his eyes wide and said, "They are not going to talk to you. How it works here is they have amenity and don't have to talk with you." At that point the situation was escalating with Marvin getting agitated and extremely uncooperative. I broke contact with him and notified Lt. Popochock of the situation. Lt Popochock went and spoke with Marvin while I stayed at the scene.

Lt. Popochock returned to the scene and informed me that Marcy Mead was the initially 911 caller and went inside the male's tent on instruction by the dispatcher. She saw the male on the floor and relayed informing to dispatch, then AID arrived on scene. Gary Padeker was in "tent 16" and heard noised from inside "tent 15." He is the one who notified Mead of what he heard but he never went inside the tent.

Marvin came to the scene and informed me that the deceased male's was possibly a "James Wasser". A female approached Lt. Popochock and said she knew the deceased man from high school and his name was "James Wosser." NORCOM conducted a check of all three provided names and the DOL photo matched to James J. Wosser (DOB: 09/22/61).

I contacted the Medical Examiner's Office and they informed me that they would be responding to the scene. Also, Detective Mangione was notified, arrived on scene, and took control of the scene. Please refer to Detective Mangione's report for further details.

The Medical Examiner arrived on scene and took custody of the body after their investigation. Please see M.E. Case #14-01191 for further details.

After the scene was cleared by the Detective Mangione and the M.E. Office, the tent and its belongings were released to the camp.

SUPPLEMENTAL:

On July 1, 2014 I responded to Tent City 4 for a death report. I contacted Officer Crist at the front entrance. Crist advised me that she was trying to get witness statements from a few people that initially witnessed the victim having a seizure. She said "Marvin" at the front desk told her they will write their statements out but they are not going to talk to officers nor are they going to give us their names.

Marvin walked over to me and proceeded to tell me the same thing. He said that the homeless already feel violated and by giving their names they feel violated all over again. He went on to say that we are violating the person's rights. Marvin also said that he knows how officers treat homeless people when they contact them on the street. Officers are insensitive to the homeless.

After dealing with Marvin I proceeded to the scene at the back of the camp. I observed victim James lying on the ground in front of his tent. I could see a hypodermic needle with an orange cap on the floor in his tent.

A male who would only identify himself as Kerry Brown walked up to the scene. He told me that he had been with James earlier in the day. Kerry said James got up at 0730 and had coffee. At 1100 he saw James leave in a car with a female. He returned at about 1145 and had a guitar and another bag with him. Kerry said James went to the smoke shack at about 1230 and was talking with him. James was excited for the following day because he was getting paid. After James finished smoking he went back to his tent. This is the last time Kerry remembers seeing James. Out of nowhere Kerry told me James was diabetic and not a drug addict.

I waited at the scene until the Medical Examiner arrived. I followed the ME out with the victim and signed off on their property sheet. At no time did I touch the victim or anything at the scene.

This concludes my involvement in this case.

Follow Up:

On 07/02/14 at approx. 2400 Hrs. I was called at home to respond to a death investigation located at 15727 NE 4 St. The area in question was inside "Tent City 4" which was set up adjacent to the Temple (west side) at the listed address.

I arrived at approx. 0023 Hrs. and contacted Ofc. Crist who advised me that the initial call was a medical call for a seizure patient. The fire department arrived on scene and performed life saving measures but was not successful. The police department was then called to investigate. The identity of the person was unknown and the staff at Tent City 4 was uncooperative in providing police with the Vict's identity. During the course of the investigation, Ofc. Crist saw drug paraphernalia inside the Vict's tent. Ofc. Crist then advised that the medical examiner's office had been called and they were en route.

I viewed the Vict. lying on the ground in front of his tent. The Vict. was lying in the supine position and was fully clothed wearing a t-shirt, jeans and shoes. Attached to the Vict. was medical intervention equipment on his body which was left in place by aid personnel after they ceased life-saving efforts. The medical equipment left behind was the following:

1. Resuscitation device left in the Vict's mouth.
2. Intravenous line and solution bag in the Vict's left arm.

I then photographed the Vict. in place then began to view the contents of the tent while waiting for the M.E. Investigator to arrive. While viewing the Vict., I observed what appeared to be 2 needle marks beside each other on the inside of the Vict's right arm in the area of the elbow. It is unknown as to the age of the marks but given the redness, it appeared as though they might be relatively fresh marks. There was no blood in this area to indicate that they were recent marks that might relate to this call, however, the autopsy would be able to provide additional info.

As I viewed the interior of the tent I noticed syringes on the floor of the tent, copper mesh, cotton, tissue, lighters, glass crack/meth pipe and a small make shift pot for cooking drugs. I photographed these items and later confiscated them as evidence.

During the course of the search I also located prescription medicine bottles in the name of James Wosser. At this approx. time Ofc. Crist advised me that Tent City 4 staff was beginning to cooperate and provided the name of the Vict. which was then confirmed with a photograph from prior police contact.

The M.E. Investigator then arrived on scene and photographed the scene. The body was turned over and the Vict's wallet was removed from his left rear pants pocket and his identity was confirmed via WA. State Driver's license.

The M.E. then emptied the Vict's right front pants pocket and removed a glass crack/meth pipe and tissue. In the left front pants pocket was the Vict's cell phone. All of the items found on the Vict's person were retained by the M.E. Investigator during the autopsy. These items would later be returned to me as possible evidence in this case.

At my request, Ofc. Crist then conducted an inventory of the Vict's medications and noted several medications. Not all medications were in their appropriate bottles.

Given the location of where the Vict. died and the lack of security for the Vict's medications, I seized the medications and drug paraphernalia for safekeeping pending the outcome of this investigation as determined by the King County Medical Examiner. The remaining items belonging to the Vict. were put in the care of the administrators of tent city. They were advised that this would be considered a landlord tenant situation where they would be responsible for the security and storage of the Vict's belongings under the landlord tenant laws. The administrators on site understood and locked the Vict's tent that night with the intention of gathering and boxing the Vict's property the following day. Several overall photos of the Vict's property were taken to document what was left behind and were submitted with this case.

On 08/29/14 I received the autopsy report from the King County Medical Examiner's Office. The report stated the following:

On March 24, 2014 I met with staff from Temple B'nai Torah (TBT) and members of Tent City 4 at the Temple in compliance with the "meet and confer" requirements of their application to host Tent City 4 (TC4). Present at the meeting were Scott Morrow (SHARE¹), four current residents of TC4 to include Cynthia Moss and Donald Casey, Toni Pratt from the City of Bellevue Land Use department, Rabbi Jim Mirel, Howard Wassertail (TBT), Cliff Cantor (TBT), and Rob Schatz (TBT). The anticipated move-in date for TC4 at TBT will be May 30, 2014. The upcoming encampment will be the 4th time that TBT has hosted TC4.

Prior to this "Meet and Confer", members of the Police Department have been present at other public meetings regarding TC4. Those previous meetings provided us with feedback from the public in regards to TC4. In addition, I conducted "due diligence" investigations as to public safety concerns that other jurisdictions experienced during recent TC4 encampments. I also communicated with three citizens who voiced concerns regarding TC4; one of the citizens is a neighbor of TBT. Additional information was gleaned from reviewing "open source" information available on-line. In preparation for an earlier "Meet and Confer" visit that took place at TBT on March 18, 2014 I prepared a document entitled, "Law enforcement concerns regarding TC4" (see attached).² The foundation of the concerns were as a result of the following information learned during my due diligence investigation:

Those reports included details of the alleged drug supplier, their name and vehicle description, schedule of deliveries, and amounts. <u>At least a couple of the drug transactions took place inside the confines of TC4 and were witnessed by sheriff's detectives.</u> The seized meth subsequently tested positive. A third case that remains sealed due to the on-going investigation detailed other aspects of the drug trafficking.</p> <p>(During the meeting I attended on March 24, 2104 TC4 members admitted that one of the <u>arrested suspects had been a member of their camp council - "EC" or Executive Committee.</u> <u>They disputed the credibility of the post-arrest confession(s) stating that it was a "plea deal".</u> <u>I pointed out that the suspect admitted to selling drugs within a thousand feet of three schools, that these admissions will double his prison time, and that his statement made against his own interests had credibility.)</u></p> <p><u>The rape allegation remains sealed as an active investigation.</u></p>

With regard to my request that TC4 makes an affirmative notification to all campers that they have permission to call 911 to report a violent crime without first having to obtain permission from the camp council, Scott Morrow said that the allegation was "a lie" but that he would make it clear to residents that they are free to directly call 911 to report a violent crime.

With regard to the drug-trafficking investigations from Sammamish PD, the TC4 members – including Scott Morrow – said that their published Code of Conduct addresses such concerns and that any illegal drug activity is dealt with immediately. A TC4 member purported that the Sammamish suspect had already been barred from TC4 at the time of arrest but the police reports indicate that he was still living in the camp at the time. Toni Pratt stated that the Code of Conduct was insufficient to prevent or address that type of behavior and that more oversight needed to be done. The TC4 members then discussed how the camp recently went into "receivership" which they described as an intensive review of their conduct policies to identify possible causes of the recent negative activity. They promised that changes to improve internal conduct were already underway.

The last bullet point was met with extreme resistance by Scott Morrow. That request involved a change in the way newcomers were screened for outstanding warrants. The long-standing method involved the camp security screener calling the King County Sheriff's Office dispatch to run newcomers for warrants. In the event the newcomer did not have an outstanding warrant the camp security would be quickly told that the person was clear. In the event that a warrant popped up a longer process was triggered: KCSO would have the camp caller on hold while KCSO reviewed the details of the warrant to include physical description, name and DOB consistency, and whether or not the warrant was extraditable. KCSO would then need to contact the local jurisdiction's dispatch center, relay the warrant information/details, and then the local dispatch center would create a call and dispatch an officer.

This inherent yet easily remedied delay allows the fugitive time to flee the area. When Camp Unity came to Bellevue last Fall, the KCSO dispatch center notified BPD that they would no longer be running warrant checks for encampments that were located within local municipalities. I worked with our communications center – NORCOM – and came up with a process for verifying warrants for camp security staff. This process was implemented and allowed for an almost immediate dispatch of Bellevue officers when an outstanding warrant was located. This improves our governmental efficiency (multiple police units aren't required to search a neighborhood if the warrant suspect can be located and arrested at/near the encampment) and enhances neighborhood safety and livability. Scott Morrow is opposed to this proposed warrant confirmation process on the grounds that it is unconstitutional, shows prejudice against the homeless, and that he doesn't trust local law enforcement with that kind of information. He stated that he would not agree to any such change.

For the reasons outlined immediately above and the serious, recent criminal activity reported by outside agencies, I believe that the NORCOM-notification process should be mandated. Additional BPD records are being reviewed at this time so that I can report out on our historical response to TC4 fugitives and the rate of successful apprehension.

Law enforcement concerns regarding TC4:

- According to named citizens, the camp council allegedly does not allow anyone to call 911 without checking with them first. In some instances, women were later kicked out of the camp after they called 911 to report a violent crime. The camp council allegedly kicked them out because they failed to check with the council before placing the call. BPD requests that the camp council notify all camp residents that they can call 911 immediately to make a direct report of a violent crime.
- Bellevue PD is in receipt of KCSO case reports that document alleged widespread meth and heroin use and sales while TC4 was at Mary Queen of Peace (as of January 7, 2014). The preliminary information I have from reviewing the police reports seem to validate the problem. The TC4 Code of Conduct prohibits such behavior yet it somehow happened. What has TC4 done in the past nine weeks to identify, address, prevent, and report to the police any such similar activity that might occur in the future?
- Starting with Camp Unity in Bellevue in October, 2013, the King County Sheriff's Office has deferred newcomer warrant checks to local municipalities when hosting an encampment. The Bellevue police department worked with our dispatch center (NORCOM) and came up with a warrant check process that worked efficiently for the remaining weeks that Camp Unity was in Bellevue. This is also a safety issue in that when doing the checks through KCSO the old way, there was an inherent delay with them contacting BPD to let us know that a fugitive was present at the camp. This inherent delay allows time for a fugitive to leave the area and evade arrest. In those instances the fugitive would be at large in the neighborhoods. BPD requests that NORCOM is contacted for all newcomer warrant checks for the reasons outlined above.

Neighbors request of the Temple:

- A neighbor I contacted at length last week requested a point-of-contact with the hosting Temple so that they can report nuisance problems that don't rise to the level of police notification. The TBT apparently had a disposable cell phone that temple staffers would answer when the neighbors called. The citizen I talked to said that there was little to no follow-up with the original neighbor caller. They would like a similar point-of-contact/phone established for any future nuisance problems and to have someone from the Temple respond back to them within 24 hours regarding their complaint resolution.
- In terms of camp transparency, the neighbor suggested that the Temple be given a weekly roster with the full names of the campers (the police would not have access to this unless needed to investigate a crime or in an emergency).

Washington State Criminal Justice Training Academy in 1985 which consisted of over 440 hours of training. Since that time your affiant has completed in-excess of 17 specialized narcotics training courses which have included basic and advanced narcotics identification, undercover/covert narcotics investigations, narcotics concealment and interdiction training, and various department legal update courses. Your affiant had also received training in the identification and processing of clandestine methamphetamine labs in 2001 and had been an active member until Jan 2011 when the group was disbanded. Your affiant has also received training in evidence collection and crime scene processing.

Your affiant has successfully applied for and/or executed in-excess of 200 narcotics related search warrants and been involved in in-excess of 600 narcotics related investigations. I have conducted undercover operations, where I have purchased controlled substance through the use of police informants on at least 75 occasions

Your affiant's current responsibilities as a plainclothes Detective include addressing problems of a criminal nature, including but not limited to; narcotic sales and use, property crimes, vandalisms, surveillance, assaults, and any other criminal matters in addition to assisting other Department Detectives or area agencies on their cases as required.

PROBABLE CAUSE:

In October 19th, 2013 Tent City 4 aka "TC4" moved into an area behind the Mary Queen of Peace Catholic Church located at the address of 1121 228th Ave SE in the city of Sammamish. I know that the Share Wheel group has been sponsoring Tent City encampments in the greater King County area for approximately 10 years and that they move every 90 days.

On 11-15-2013 a citizen intentionally stopped by the city of Sammamish and complained to Sammamish Sgt P. Horvath of rampant drug and alcohol use among the tenants of TC4. The citizen advised that methamphetamine and marijuana use was being blatantly used and sold among the people staying there. Further that the executive committee was very aware of the drug activity and was not doing anything about it. I was present during part of the contact in the Sammamish sally port on a non-related detail and heard some of the conversation. As it was a city of Sammamish matter I did not get actively involved in the conversation.

On 11-04-13 Deputy C. Bowthorpe met with a subject that was currently staying at TC4 who complained of rampant drug use including heroin and methamphetamine use and sales in addition to marijuana use by tenants of TC4. Subject complained that the executive committee was involved in the blatant drug sales by running interference for the dealers who live in TC4. The subject continued that if they thought someone in TC4 was an undercover cop they would "bar" them IE expel them so as to protect the drug use in TC4 from the perceived threat.

On 11-29-2013 I met with a subject currently staying at TC4 who complained of rampant drug use including heroin and methamphetamine in addition to marijuana by the tenants of TC4. The subject advised that he/she brought this issue up with the executive committee of TC4 and was told if he/she caused any problems or called the cops for any reason he/she would be "barred" aka kicked out immediately.

On 11-18-2013 at 1400 hours I met with a cooperating citizen who has previously stayed at TC4 in Sammamish. The cooperating citizen does not want to be identified for fear of retaliation and the hope that he/she may be able to return to stay at TC some day in the future.

He/she said that Andy, Brandi, and Victor are the main meth dealers in TC4 and that Keven w/ his roommates Dustin and Mikey are the main heroin connections and that they (Keven, Dustin, and Mikey) live together (heroin group) in the same tent. He/she described where they are all located within TC4 and found them to be grouped in the "playground area" in the NE corner of the camping area. Citizen advised that he/she had bought methamphetamine from Andy approximately 8-10 times and that his cell phone number is 206-981-6044. Citizen estimates that about ¾ of the people in TC4 do hard drugs, specifically methamphetamine and heroin. Further that Andy Abad has approximately 1 ounce of methamphetamine delivered by a female in her mid-20s named "Erin" who arrives as a passenger in a full-size early/mid 80's dark blue Ford Bronco w/ loud exhaust and a dent in the left rear corner driven by an older white male adult w/ gray hair approximately once a week.

On 11-18-2013 at 1547 hour [REDACTED] was contacted by the Sammamish Police Department and taken into custody on his valid city of Maple Valley warrant for Possession of Drug Paraphernalia issued 11-18-2013 under warrant number 246291MV and KCSO 13-297414. Upon being taken into custody [REDACTED] was found to be in possession of 1.3 grams of methamphetamine. [REDACTED] acknowledged that he was living in TC4 and sells methamphetamine for "Andy" Abad and for himself. [REDACTED] appeared to be under the influence of narcotics upon being taken into custody and acknowledged that he would be willing to talk with a Detective at which time I was called. Upon arrival Det Przygocki and I sat down with [REDACTED] in the city of Sammamish interview room. I asked [REDACTED] about his living in TC4 and his drug use. [REDACTED] said he has bought methamphetamine from Andy 35-40 times and in turn would sell some of it while keeping some for himself. He said he had bought the methamphetamine he was caught with from Andy Abad. He acknowledged that he had borrowed Andy's cell phone and that the number for it was 206-981-6044. [REDACTED] had a cell phone in his possession at time of arrest. I looked at the phone and verified that the number assigned to it was 206-981-6044. This matched the phone number given to me only 3 hours earlier by the cooperating citizen. [REDACTED] acknowledged that the warrant stemmed from an incident last year where he overdosed on heroin. He said that he only does methamphetamine now. He said he was just kicked out of TC4 for rules violations but had been living in TC4 since it was in Redmond back in Sept/October of 2013.

Upon inquiry [REDACTED] mentioned the names of people involved in the sales of narcotics within TC4 including Andy Abad, Victor, Tina, and Brandi. He also talked about a female named Erin that delivers meth to Andy each week. [REDACTED] said that he believed that Andy Abad was the biggest supplier of methamphetamine to the people of TC4 and that at least 85-90% of the people living in TC4 are currently doing hard drugs including methamphetamine and heroin. [REDACTED] estimated that when he was kicked out that there were still about 75 people living there. [REDACTED] agreed to buy methamphetamine from Andy Abad at my direction in the consideration of leniency in the filing of charges for the methamphetamine that he had in his possession at time of arrest.

[REDACTED] has provided information regarding the criminal behavior of others that has been independently corroborated by me. [REDACTED] has proven to me that he/she is knowledgeable in narcotics identification, packaging, sales and personal use amounts. [REDACTED] has made statements regarding his/her drug use against his/her own penal interests. [REDACTED] knows that he/she may be prosecuted for making a false statement and will not receive judicial consideration in his/her non-violent drug charges.

A NCIC Triple I reveals that [REDACTED] has no convictions for crimes of dishonesty. A check of [REDACTED] through Western States Information Network (an information clearinghouse that reports whether there has ever been reason reported by law enforcement not to trust an informant or rely upon the information they provide) contained no negative information regarding this CI's reliability.

[REDACTED] has discussed his/her past drug use and his /her knowledge of drug use and trafficking with me to the extent I am confident that [REDACTED] has knowledge thereof. This information was consistent with my experience related to narcotics investigations. The information provided by this informant has consistently been found to be both reliable and credible.

On the evening of 01-02-2014 [REDACTED] was provided with \$20 in King Co SO buy monies for the purpose of purchasing methamphetamine from Andre "Andy" Abad at my request. [REDACTED] said that he could still walk right into TC4 to buy from Andy and that nobody would care. [REDACTED] was then searched before being provided the monies and was found to not have any additional monies or controlled substances on his person. [REDACTED] was then observed by surveilling Detectives walking into the TC4 area behind the church itself and out of sight. Approximately 9 minutes later [REDACTED] was observed exiting the TC4 area at which time he returned to a nearby location to meet with me as previously agreed. Upon contact [REDACTED] turned over a small light blue transparent ziploc being 3/4" x 1" in size that contained a small amount of crystalline substance which I took possession of. I then again searched [REDACTED] and found him to be clear of any monies or additional controlled substances. [REDACTED] provided a written statement that he had gone into TC4 and went to Andy Abad's tent and purchased the methamphetamine from him for \$20. He said that Andy told him he was almost out and was expecting Erin to bring more tonight that night at midnight. [REDACTED] described Abad's tent as a very large dark blue square tent w/ a dark colored tarp over it. He continued that the door to the tent physically had a handle on it that sticks out. He described the tent as being just inside the gate and is the 2nd tent on the left. He said that due to TC4 rules Abad now has to have a tent roommate. This is apparently because he is living in such a big tent and space is at a premium. He said that Andy Camp lives with him. Everybody calls him "Camp". He continued that although Camp is now living with him Camp is not involved in narcotics trafficking even though it is occurring in his presence. Camp has been identified as Andrew Joseph Eli Camp WMA DOB 10-23-1990. I then conducted a field test of the crystalline substance purchased from Abad using narctest's #2 and #23 which I have been trained in the use and application of. The substance purchased was found to contain methamphetamine and weigh out at 1/10 gram which was documented under KCSO 14-001424.

On January 6th CI KC2-213-007 contacted your affiant and advised that he/she had just met with Andy Abad and purchased methamphetamine from him at TC4. KC2-213-007 has been a non-transactional confidential informant for your affiant and Deputy Mike Broderick for over 15 years and has provided information in a confidential capacity which has led to the recovery of stolen property and arrests in the past. As this had not been a scheduled controlled buy I had not been able to conduct a pre-buy search and provide proper KCSO buy funds for that purpose.

Upon meeting with KC2-213-007 at a nearby location in close proximity to TC4 he/she turned over a small transparent blue ¾" x 12" ziploc baggie containing a small amount of crystalline substance. I immediately recognized the ziploc baggie as exactly matching the ziploc that contained the methamphetamine that ██████ had purchased from Abad 4 days earlier on January 2nd, 2014 under 14-001424. I conducted a field test of the substance purchased by this CI using narcotest's #2 and #23 which I have been trained in the use and application of. The crystalline substance tested positive for methamphetamine.

I know that persons involved in the sales of narcotics commonly use a specific type of marked ziploc baggie so as to market themselves in a subtle but obvious way. In this case both the controlled buy on January 2nd, 2014 and uncontrolled buy on January 6th, 2014 involved the sale of methamphetamine from a subject in TC4 who was claimed to be Andy Abad. Neither ██████ nor CI KC2-213-007 know that the other is assisting on this investigation yet both purchases of methamphetamine were made using identical transparent blue ziploc baggies that measure ¾" x 1" in size. Transparent blue ziplocs are fairly uncommon as compared to commonly seen plain ziplocs or ones w/ an 8-ball, batman, skull, or marihuana leaf logo.

On January 7th I met with CI KC2-213-007 at a location in close proximity to TC4. CI provided me with a camera phone image of a red tent behind the children's slide in the play area of TC4 and advised that is where Andy Abad is currently staying and selling his methamphetamine out of. Further that earlier in the day Abad had attempted to sell CI methamphetamine but CI did not buy any, claiming he/she was out of money. CI advised that there has literally been a line of up to 3-4 people at times waiting at the entrance of his tent to buy methamphetamine. CI advises Abad has a green lockbox that he keeps his drugs and stolen coupons in and has a key for it with his ORCA transit card around his neck. Further that the coupons were donated to TC4 by area businesses but that they were stolen from TC4 by Abad. CI advises these thefts are not reported by TC4 as they do not want any bad publicity. CI has been told by the executive committee that if he/she calls the police for any reason CI will be barred from TC4.

The plan for January 9th, 2014 is to provide ██████ with \$40.00 of pre-recorded KCSO buy money. Once Detectives are in place ██████ will walk into Tent City 4 aka "TC4" and meet with Andrea "Andy" Abad with the recorder on, for the specific purpose of buying methamphetamine from him as he has done numerous times in the past. Before walking into the area, Detectives will search ██████. ██████ will be monitored during the entire operation and followed to and from a predetermined nearby location. Once ██████ returns to the predetermined location, Detectives will again meet with him, collect the evidence, and again search him for any additional monies or contraband.

The trial of a narcotics case is frequently reduced to a one-on-one swearing contest that frustrates a factual resolution of what is said by whom. Possession of the actual contents of the video and audio capturing the transaction minimizes any factual confusion, clarifies the issues and is superior to inexact recollections from witnesses. No more reliable evidence of the physical actions and communications is available than a recording, or recordings, of the actual conversations. The spoken words and physical actions are themselves the best evidence of criminal intent. No other investigative method is capable of capturing these words and actions in such clear and admissible evidentiary form.

Re: TC4 (BELLEVUE) WARRANT CHECKS

I know the fact that we are still doing warrant checks for TC4 while it is located in Bellevue is frustrating, and seems to defy the usual jurisdictional roles. I want to assure you that I have taken the steps available to me to try to change this responsibility to Bellevue PD, and that they are willing (eager, even) to accept it, but there are other considerations in play. The County Exec (or his staff) made a promise to the entity that created and supports the tent city that – regardless of jurisdiction – the Sheriff's Office would do the warrant checks. This is a promise we are still expected to support, and one that I have been unable to change. Therefore, we are obliged to continue doing these.

Bellevue PD has discovered that when we run a name that has a warrant associated with it, and we transfer the call to their dispatch center that this "longer than usual time on the phone" seems to cue the bad guy to high-tail it out of there. We have been asked to change our procedure somewhat, in order to lessen this likelihood. Effective immediately, when you have run a name for a TC4 staffer and the name has an associated warrant, just say what you usually do to the caller. Then, immediately upon disconnecting, please call Eastside Communications and let the operator know that you ran a name for TC4, got a hit and offer the subject's information. I have received a suggestion that we might incorporate using AC and Metro as possible alternatives to transferring the TC4 staffer to secondary when there is a long wait; this is acceptable if the transfer will not interrupt the work normally in progress at either of those radios. The other tack I am trying is to get word to the TC4 staff *not* to hang up and call back, as that does not get them assistance faster.

Temple B'nai Torah Site → 5 Warrant Arrests*
Nov 18, 2005 6 Warrants with no arrest + no report, in 5 subject gone
Found Property Report OSB-13270 + not located, 1 was located in neighborhood
A driver's license was found in the desk at the TC4 reception area and BPD was called. The officer contacted the owner and determined their wallet had been stolen in Seattle between the dates of 9/25/2005 and 10/05/2005. It was unknown when or how the license ended up in the desk at TC4. Written report taken and license mailed back to owner.

A subject was attempting to check in at TC4 and as a result of the records check, it was discovered he had an outstanding Auburn misdemeanor warrant. Subject was arrested without incident and turned over to an Auburn PD Officer.

TC4 called to advise a subject was there with an outstanding warrant. Subject left prior to officer arrival and was not located.

TC4 called to advise a subject was there with an outstanding warrant. Subject left prior to officer arrival and was not located.

TC4 called to advise a subject was there with an outstanding warrant. Subject left prior to officer arrival and was not located.

TC4 called to advise a subject was there with an outstanding warrant. Subject left prior to officer arrival and was not located.

Warrant Arrest OSB-13965
A subject was attempting to check in at TC4 and as a result of the records check, it was discovered he had an outstanding no bail Dept. of Corrections warrant for Escape. BPD was called and subject was arrested without incident. According to the subject, the warrant was supposed to have been quashed that day. DOC later sent a teletype requesting that the subject be released from custody (apparently because the warrant had been quashed). Subject was given a courtesy transport back to TC4.

Theft 05B-14926

Resident of TC4 called to report items were missing from his tent. He had been working in Seattle for the previous two days and returned to find the items were missing. Value of loss was \$143.

Jan 1, 2006

Found Property Report 06-0034

A neighbor of TC4 living on 157 Ave NE called BPD to report they found a blue bag containing prescription medication and vitamins. The neighbor thought it may belong to a TC4 resident. The officer checked the name on the prescriptions with the staff at TC4. The name did match a resident of TC4, however, the resident had not been seen for the past 2-3 days. The officer left a business card for when the resident returned to TC4 and booked the found property into evidence for safekeeping.

Jan 2, 2006

Subject Contact FIR

Two TC4 residents were contacted in the 14200 block of Lake Hills Blvd. They were "talking loudly under a stairway". No warrants or other charges. *

Jan 6, 2006

Verbal Disturbance No report

Union 76 Station in Crossroads

Union 76 employee called 911 to report he had a verbal disturbance with 2 transients over buying cigarettes. It was determined the male subject lived at TC4. Subjects left prior to officer arrival. No crime occurred. *

Jan 6, 2006

FBI Request No report

FBI made a request that we check TC4 for a suspect they were looking for as they had received a tip that the subject was a TC4 resident. Subject was wanted for Unlawful flight to avoid prosecution - Lewd and Lascivious Assault upon a Child and Probation Violation. Due to the nature of the crime reportedly committed by the subject, I requested Officers to immediately respond to TC4 to determine if the wanted subject was there. Officers went to the site and determined a subject with the same name had been staying in TC4, but had left 3 weeks previously. Upon checking the identification information on the TC4 resident, it was determined they were not the same subject being sought by the FBI (different dob, Social Security number, physical description, and birth place). FBI was re-contacted and provided that follow-up information.

Jan 7, 2006

Warrant Subject No report

TC4 staff called to report that it was believed a current resident had an outstanding felony warrant under a different name. Various names provided were checked through the system and no warrants were discovered.

Jan 9, 2006

Warrant Subject No report

TC4 called to advise a subject was there with an outstanding warrant. Subject left prior to officer arrival and was contacted in the neighborhood. Subject had a non-extraditable warrant out of Tacoma for \$750. No arrest.

Citizen living near TC4 reported unknown person smeared something like a baked fruit on top of their mailbox. Citizen believed the incident was caused by TC4 resident. No witnesses or evidence to substantiate that claim. damage, just time loss for cleaning up the mess.

Jan 23, 2006
Theft 1 / Burglary 2 Arrest 06-0922 and 06-0930
TC4 resident was arrested for committing theft and burglary at Party City in Crossroads Mall. Loss was valued at \$1550. It was also determined that the same subject committed a burglary at Pier 1 Imports (also located in Crossroad's Mall) taking property valued at \$305. Search warrant was served on his tent and some stolen items were recovered. Prior to the suspect's arrest, a member of the Executive Committee at TC4 had told him that we were looking for him. This was brought up with the Temple Staff and other Executive Committee members, who properly addressed the concern.

This is not consistent with what we were told at the Bhai Torah Meeting on 3-18-2008 when we brought this incident up

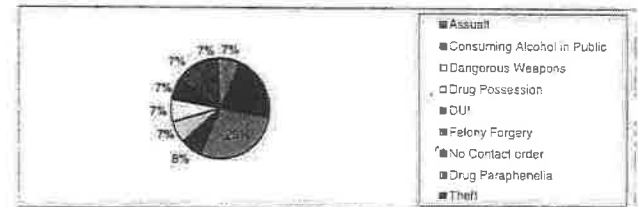
51 individual declarations signed July 20, 2008 stating they are a current TC4 resident. *at B'nai Torah*
 These also came from discovery in Mercer Island
 10 of the 51 individuals or roughly 20% committed crimes while in TC4. Given 93 of the 100 residents came from the previous encampment and each of the 51 declarations indicated a desire to move to Mercer Island, we believe they may still be residents of TC4.

15 crimes and arrests occurred while the individuals were residents of TC4.

10 of the arrests resulted in convictions.

5 cases are still pending. *when this was done*

3 of 10 have outstanding warrants. *2 were arrested by ME Police when this chart was given to them, one wasn't.*



*Colley lived at Northshore United Church- Where Crime first took place (Woodinville May- August 2006), Woodinville Unitarian (August- November 2006), St. John Vianney (Finn Hill Nov. 2006-Feb 2007), St. Jude (Redmond Feb-May 2007), Church of the Resurrection (Bellevue May -August 2007), Community Church of Issaquah (Aug), JAILED Sept- Dec. 2007, 1/5/2008 returned to Holy Spirit Lutheran, Temple B'nai Torah (Bellevue May-Aug 2008)

Was finally asked to leave when this became public in Mercer Island. TC4 + Sharewheel claimed to have never known about any of this, although she had the victim came to a site, the police came to speak to her at another site, she went to + from court + jail from TC4 sites, + then came back to TC4 after her jail term was up

I've lived in Seattle since 2005. In April 2013, I moved from Capitol Hill to Bellevue, for more living space. Added bonus was moving away from all of the homeless problems I encountered living in Capitol Hill and working in Belltown. Imagine my shock and surprise this past May when I was reading Bellevue's little blue "Projects" Bulletin and discovered B'Nai Torah's plans to bring a Tent City less than 300 yards away from my new home (technically, less than 200 yards away).

As a neighbor, less than 300 yards away from a Tent City, I was not notified by my neighbor the Temple in enough time to affect any of the permit process and was quite livid about that. After the fact, As a neighbor and city taxpayer, I was not engaged by anyone from a single homeless advocacy group nor a single councilperson regarding how I, my safety, or well-being was impacted by a Tent-City having been in my neighborhood for 92 days. Nice to see things haven't changed.

B'Nai Torah hosted only a single meeting to hear the concerns of the neighbors prior to the set-up of Tent City 4. That's the only back-and-forth communication that occurred. So if you think actual meetings where members of SHARE + CEHCK are listening to neighbors' input, you are quite mistaken. At said meeting, we get limited time at the end of the meeting to share our concerns, and then we rarely, if ever, hear back from the organization as to how our concerns are incorporated into their regulations. *(they usually are not).*

(I stumbled here to find my next point)

Next, unrelated thought:

The organizers who run the Tent Cities need to devise a way to track stats of the average Tent City user, so the stats can be used for tracking purposes - i.e., single adult users, vets, families, etc. How can this be considered emergency shelter if the same people keep coming back year after year? The first man who stood up to speak at this neighborhood meeting said he'd been in Tent City for seven years because of something that had happened to in his life nine years ago . . .

Then the "time" buzzer went off.
