After an early career in high tech, I left to pursue my environmental passion, most of which has involved sustainable water. Being an early green consultant led me to a focus on inefficiencies in water system engineering, particularly wastewater treatment and reuse. In 2006, I pulled together Whole Water, a group of engineers and biologists formed to offer more sustainable approaches. We have designed wastewater, greywater, stormwater and rainwater systems for very green projects. We are also developing properties in Vashon Town, as cutting-edge examples of sustainable water use.

How did you learn of this opportunity?

A current member, Gib Damman mentioned the current application process and suggested I apply. I had also heard about the committee from a friend, John Gerstle who had previously served on it. John had also suggested I consider serving based on my background and our intentions to make sustainable water a key design component of our multi-family development in the town of Vashon.
