1 AN ORDINANCE creating a single parks citizen oversight
2 board as provided for in Ordinances 15759 and 15760;
3 amending Ordinance 15759, Section 7, and repealing
4 Ordinance 15760, Section 8.

5 STATEMENT OF FACTS:

6 1. In August 2007, the voters of King County approved Proposition 1,
7 which provided property tax levy revenues for continued and increased
8 maintenance, operations, and disabled accessibility at King County's rural
9 and regional parks, and Proposition 2, which provided funding for
10 expanding city and county parks and recreation opportunities through the
11 acquisition of open space and trails, and programs and capital
12 improvements at the Woodland Park Zoo.

13 2. Proposition 1 and Proposition 2 each provided for the appointment of
14 members by the county executive to a parks citizen oversight board, and
15 each provided that if both measures were approved by the voters, the
16 county council could combine the functions of the two boards into a single
17 board.

18 3. The council finds it efficient and appropriate to create a single parks
19 citizen oversight board to address the purposes of Propositions 1 and 2.

20 Consistent with the direction of those measures, the function of the board
21 should be to review the expenditure of levy proceeds and make policy
22 recommendations to the county executive and county council regarding
23 future expenditures.

24 4. The executive should appoint board members, based on the
25 nominations of members of the council. The council should confirm
26 members of the board. The board should report to the county executive
27 and the county council annually on expenditures of levy revenues from
28 Propositions 1 and 2 of 2007, and should make any appropriate
29 recommendations on future expenditures. The board should expire on
30 June 30, 2014.

31 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

32 SECTION 1. Ordinance 15759, Section 7, is hereby amended to read as follows:

33 As provided for in Ordinance 15759, ~~((s))~~Section 6 ~~((of this ordinance))~~ and
34 Ordinance 15760, Section 7, a county parks citizen oversight board is hereby created to
35 review the expenditure of levy proceeds and make policy recommendations to the county
36 executive and county council regarding future expenditures. ~~((In the event that the
37 qualified electors of King County approve both the proposition set forth in section 6 of
38 this ordinance and the proposition set forth in Ordinance (Proposed Ordinance 2007-
39 0225), Section 7, then the council may, at its discretion, nominate and confirm the same
40 members to both boards or combine the board functions into one board.))~~ The board
41 shall consist of nine members, to be appointed by the executive. Each councilmember
42 shall nominate a candidate for the board from the councilmember's district. If the

43 executive does not appoint a person who has been nominated by a councilmember, the
44 executive must request that the councilmember nominate another candidate for
45 appointment. Board members shall be confirmed by the council. Members shall be
46 residents of King County. The chair of the council shall designate one additional person
47 to participate in board discussion, but the person shall neither vote nor be a member of
48 the board. On or before May 30 of each year beginning in 2009, the board shall review
49 and make a written report to the King County executive and the King County council on
50 the expenditure of all levy proceeds and any policy recommendations regarding levy
51 proceeds. Ten copies of each written report shall be filed with the clerk of the council,
52 for distribution to all councilmembers. The parks and recreation division shall provide
53 the board with all reports on division activities that the division transmits to the King

54 County council in accordance with K.C.C. 7.08.090. The board expires June 30, 2014.

55 SECTION 2. Ordinance 15760, Section 8, is hereby repealed.






