DETERMINATION OF NON-SIGNIFICANCE

The Responsible Official of the Renton School District hereby makes the following Findings and Conclusions based upon review of the environmental checklist and attachments, other information on file with the Renton School District, and the policies, plans, and regulations designated by the Renton School District as a basis for the exercise of substantive authority under the Washington State Environmental Policy Act (SEPA) pursuant to the Revised Code of Washington RCW 43.21C.060.

Findings of Fact:

1. The subject Capital Facilities Plan will guide the development of school district facilities over the next six years and is intended to be revised on an annual basis.
2. The plan was prepared utilizing information from the Renton School District as well as the cities of Renton, Newcastle, and Bellevue, and King County community and land use plans.


CONCLUSIONS OF THE RESPONSIBLE OFFICIAL

The responsible official has determined that the proposal does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after review of a completed environmental checklist and other information on file with the Renton School District and existing regulations. 

There is no agency administrative appeal under Renton School District SEPA policies. Pursuant to RCW 43.21C.075 and the Renton School District SEPA Rules, decisions of the Responsible Official may be judicially appealed.
