NOTICE IS HEREBY GIVEN that a Notice of Intention has been filed with the King County Council relating to the annexation of approximately 4.61 acres of land into the Midway sewer district, known as the Westwood Sewer BLA annexation, for the purpose of sewer service. A public hearing before the Metropolitan King County Council is to be held in Room 1001, King County Courthouse, on Monday, April 28, 2014 at 1:30 p.m.

A description of the proposed area to be annexed is as follows: Exhibit B The West 160 feet of the North 65 feet of the South half of the Southwest quarter of the Northeast quarter of the Southwest quarter of Section 32, Township 23 North, Range 4 East, W.M. Records of King County, Washington; Together with lots 1, 2 and 3 of Tinscher addition, according to the plat thereof recorded in volume 65 of plats, page 84, records of King County, Washington; Together with that portion of the east 70 feet of the west 230 feet of the south half of the southwest quarter of the northeast quarter of the southwest quarter of said section 32 lying south of the easterly projection of the north line of lot 2 of said Tinscher addition; Together with Lots 1 and 2 of Westwood Ridge, according to the plat thereof recorded in volume 263 of Plats, pages 59-61, records of King County,
