**SUMMARY OF RECOMMENDATIONS:**

<b>Department's Recommendation:</b>	Approve 8.05 acres for 40% of assessed value; conditionally approve 30% of assessed value and potentially an additional 0.68 acres.
<b>Examiner's Recommendation:</b>	Approve 8.05 acres for 40% of assessed value; conditionally approve 30% of assessed value and potentially an additional 0.68 acres.

**PRELIMINARY REPORT:**

On April 8, 2020, the Department of Natural Resources and Parks (DNRP) submitted its report on file no. E19CT031 to the Examiner.

**PUBLIC HEARING:**

After reviewing the preliminary report and examining available information on file with the application, the Examiner conducted a telephone hearing on the application on April 23, 2020.

Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Hearing Examiner's Office.

**FINDINGS AND CONCLUSIONS:**

## 1. General Information:

2. The Applicants timely filed an application to King County for the Public Benefit Rating System (PBRS) program current use valuation of the property to begin in 2020. As required by law, notification of the application occurred.

3. A summary of relevant PBRS categories follows below. (Plain text represents a category an applicant requested an award for and that DNRP agrees is warranted. Any ~~strike through~~ represents a category an applicant requested an award for but DNRP disagrees is warranted. Any *italics* represents a category an applicant did not request an award for, but DNRP nonetheless concludes is warranted. And any \*asterisk\* represents a category where DNRP finds an award is warranted, but only if certain contingencies or conditions are met.)

4. The DNRP-recommended score of 15 points results in a current use valuation of 40% of assessed value for the enrolling 8.05 acres.
5. An additional 5 points may be awarded administratively under the forest stewardship land category, subject to a forest stewardship plan being provided to DNRP by **October 1, 2020**, and approved by DNRP by **December 31, 2020**. This would increase the point total to 20, drop the current use valuation to 30%, and potentially allow approved forestry activities to occur on the property. If the plan suitably addresses restoration of 0.68 acres of the property heavily impacted by invasives, award of this credit would also increase the enrolled acreage to 8.73; at the time of hearing, it appeared unlikely the Applicants would pursue this aspect.
6. As to the land area recommended for PBRS enrollment, the Applicants requested 5.00 acres and DNRP recommends 8.05 acres. (Enrollment acreage is the entire parcel less the excluded area, as calculated by DNRP. In the event the County Assessor's official parcel size is revised, the PBRS acreage shall be administratively adjusted to reflect that change.)
7. Except as modified herein, the facts set forth in DNRP's preliminary report and testimony at the April 23, 2020, public hearing are correct and incorporated herein by reference. Copies of this report and DNRP's report will be provided to the Metropolitan King County Council for final approval.
8. Approval of 15 points (and a current use valuation of 40% of assessed value for the enrolling 8.05 acres) and conditional approval of 5 additional points (and 30% of assessed value for acreage potentially increasing to 8.73) are consistent with KCC Chapter 20.36 and with the purposes and intent of King County to maintain, preserve, conserve, and otherwise continue in existence adequate open space lands and to assure the use and enjoyment of natural resources and scenic beauty for the economic and social well-being of King County and its citizens.

RECOMMENDATION:

1. APPROVE a current use valuation of 40% of assessed value for the 8.05-acre enrolled portion of the property.
2. CONDITIONALLY APPROVE a current use valuation of 30% of assessed value for the 8.05- (potentially 8.73-) acre enrolled portion of the property.

## NOTICE OF RIGHT TO APPEAL

A person appeals an Examiner recommendation by following the steps described in KCC 20.22.230, including filing with the Clerk of the Council a sufficient appeal statement and a \$250 appeal fee (check payable to the King County FBOD). Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal. KCC 20.22.230 also requires that the appellant provide copies of the appeal statement to the Examiner and to any named parties listed on the front page of the Examiner's recommendation.

Prior to the close of business (4:30 p.m.) on *June 1, 2020*, an electronic copy of the appeal statement must be sent to [Clerk.Council@kingcounty.gov](mailto:Clerk.Council@kingcounty.gov) and a paper copy of the appeal statement and the \$250 appeal fee must be mailed to King County Council Clerk at 516 3rd Ave, Room 1200, Seattle, WA 98104, by first-class USPS mail, postage prepaid, postmarked June 1 or earlier. For tracking purposes, you may want to consider using USPS "Priority Service," which will allow you to track delivery. Due to the Governor's 20-25 proclamation "Stay Home – Stay Healthy," the King County Council Clerk is no longer accepting in-person delivery of appeals.

Unless both a timely and sufficient appeal statement and filing fee are filed by *June 1, 2020*, the Clerk of the Council shall place on the agenda of the next available Council meeting a proposed ordinance implementing the Examiner's recommended action. At that meeting the Council may adopt the Examiner's recommendation, defer action, refer the matter to a Council committee, or remand to the Examiner for further hearing or further consideration.

If a timely and sufficient appeal statement and filing fee are filed by *June 1, 2020*, the Examiner will notify all parties and interested persons and provide information about "next steps."
