Ordinance 19042

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Wednesday, December 11, 2019, beginning at 9:30 AM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2019-0437 (Ordinance 19042), an ordinance adopting findings in support of and renewing and extending a moratorium under RCW 90.58.590 and RCW 36.70A.390 on the establishment of new or expansion of existing major fossil fuel facilities.
