NOTICE IS HEREBY GIVEN that the King County Flood Control District ("District") Board of Supervisors will hold a public hearing on the 12th day of November 2024, at 1:30 p.m. The purpose of the public hearing is to authorize a property tax levy increasing property tax revenue to implement the District's 2025 budget and work program; reserving banked capacity; and protecting up to \$.25 per \$1,000 of assessed value of the District's property tax levy from proration.

The public hearing is planned to be a hybrid meeting. You may attend the public hearing in person at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or remotely via the virtual meeting. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the District website ahead of the hearing.
