1 AN ORDINANCE relating to traffic control; removing
2 prohibitions on parking at all times on 104th Avenue
3 Southwest, on the west side from Southwest Cowan Road
4 to Southwest 110th Street, and Southwest 110th Street, on
5 the south side from 103rd Avenue Southwest to 104th
6 Avenue Southwest, on Vashon Island; amending Ordinance
7 5292, Section 7, as amended, and K.C.C. 46.04.060,
8 Schedule 14, and repealing Ordinance 9723, Section 1,
9 Ordinance 9723, Section 2 and Ordinance 9723, Section 3.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. In accordance with the department of transportation, road services
13 division, traffic engineering studies and as authorized by chapter 46.90 RCW and
14 Ordinance 5292, Section 7, as amended, and K.C.C. 46.04.060, Schedule 14, which
15 prohibits parking at all times along certain county roads, is amended to remove the
16 following roadways:

17 A. 104th Avenue Southwest, on the west side from Southwest Cowan Road to
18 Southwest 110th Street; and

19 B. Southwest 110th Street, on the south side from 103rd Avenue Southwest to
20 104th Avenue Southwest.

21 SECTION 2. Ordinance 9723, Section 1, Ordinance 9723, Section 2, and
22 Ordinance 9723, Section 3, are each hereby repealed.

23 SECTION 3. Sign removal to reflect the changes to Ordinance 5292, Section 7,
24

25 as amended, and K.C.C. 46.04.060, Schedule 14, in sections 1 and 2 of this ordinance
26 shall be performed by the proper authority.


