NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council on the 17th day of November, 2020, at 1:00 p.m., to consider adoption of Proposed Ordinance 2020-0322, adopting the restructure of the Utilities Technical Review Committee and School Technical Review Committee. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington, or the hearing may be required to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the Council's website ahead of the hearing.

**SUMMARY**

The proposed 2021-2022 King County Biennial Budget includes a reallocation of expenditure authority for the staffing and membership of the Utilities Technical Review Committee and School Technical Review Committee. The proposed changes will improve efficiency and better align staffing of the committees with the appropriate County agencies, most substantially to align with the local services and regulatory functions of the Department of Local Services. This proposed ordinance effectuates these changes in the King County Code.
