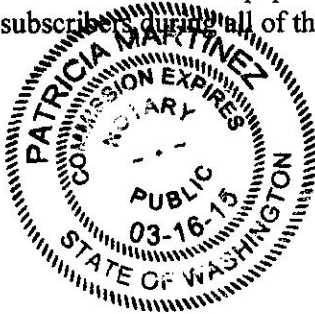

### METROPOLITAN KING COUNTY COUNCIL NOTICE OF PUBLIC HEARING

Proposed Substitute Ordinance 2014-0057

NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington on the 3rd day of November, 2014, at 1:30 p.m., to consider adoption of Proposed Substitute Ordinance No. 2014-0057 relating to transportation concurrency.

#### SUMMARY:

The concurrency map is a tool for ensuring that King County's transportation infrastructure is adequate to meet the needs of new development. The concurrency map identifies which travel sheds throughout unincorporated King County pass or fail the concurrency test, as measured by travel time standards applied to each travel shed. A proposed development must be in a passing travel shed as an initial step in the project development process. Proposed Substitute Ordinance 2014-0057 amends King County Code 14.70.270 to change the schedule for updating the concurrency map. The new schedule provides for updates in even numbered years, with transmittal of a report and, if needed, a new concurrency map to the County Council by July 31 of a transmittal year.
