## 5. <u>Metropolitan Water Pollution Abatement Advisory Committee</u> (MWPAAC)

Mr. Thomasson spoke on the Combined Sewer Overflow Plan. He noted that the Metropolitan Water Pollution Abatement Advisory Committee (MWPAAC)'s concerns on the CSO Plan raised in April: 1) the viability of the green stormwater infrastructure facilities and 2) rate impacts associated with compliance deadlines are addressed in the Striking Amendment to the CSO Plan. MWPAAC recommends trying to extend the compliance dates. He suggested two further amendments to the plan 1) the amendment to the CSO projects and schedule should be called out as an amendment to the Regional Wastewater Services Plan and 2) add a new section to the ordinance that provides a deadline for RWQC and King County Council to receive proposed legislation updating Regional Wastwater Services Plan policies on CSOs.
