1 A MOTION appointing committees to write the voters'
2 pamphlet statements for the November 3, 2015, general
3 election regarding Ordinance 18087 providing for the
4 submission to the qualified electors of King County at a
5 general election to be held in King County on November 3,
6 2015, of a proposition to amend Section 898 of the King
7 County Charter and add a new Section 265 to the King
8 County Charter, establishing a charter-based civilian office
9 of law enforcement oversight, providing the office with
10 appropriate authority to carry out its duties, establishing a
11 charter-based citizen advisory committee on law
12 enforcement oversight and making the county executive, in
13 consultation with the county sheriff, the county's
14 bargaining agent concerning civilian oversight of law
15 enforcement.

16 WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of
17 local voters' pamphlets in conformity with chapter 29A.32 RCW for annual general
18 elections held in King County, and

19 WHEREAS, RCW 29A.32.280 provides that, for each measure from a unit of
20 local government that is included in a local voters' pamphlet, the legislative authority of
21 that jurisdiction shall formally appoint a committee to prepare arguments advocating
22 voter approval of the measure and a committee to prepare arguments advocating voter
23 rejection of the measure, and

24 WHEREAS, Ordinance 18087 provides for the submission to the qualified
25 electors of King County at a general election to be held in King County on November 3,
26 2015, of a proposition to amend Section 898 of the King County Charter and add a new
27 Section 265 to the King County Charter, establishing a charter-based civilian office of
28 law enforcement oversight, providing the office with appropriate authority to carry out its
29 duties, establishing a charter-based citizen advisory committee on law enforcement
30 oversight and making the county executive, in consultation with the county sheriff, the
31 county's bargaining agent concerning civilian oversight of law enforcement;

32 NOW, THEREFORE, BE IT MOVED by the Council of King County:

33 The following individuals are appointed to serve on the voters' pamphlet
34 committee to write statements for and against the proposition to amend Section 898 of the
35 King County Charter and add a new Section 265 to the King County Charter, establishing

37 appropriate authority to carry out its duties, establishing a charter-based citizen advisory


