1           A MOTION appointing members to the governing body of  
2           the Redmond Library Capital Facility Area in accordance  
3           with RCW 27.15.030.

4           WHEREAS, in accordance with RCW 27.15.020, at the September 17, 1996,  
5           election the voters authorized the formation of the Redmond Library Capital Facility  
6           Area ("the area") in order to issue bonds to finance library facilities, and

7           WHEREAS, King County council Motion 9973 appointed the first members of  
8           the area governing body in 1996, and

9           WHEREAS, the area has served its purpose of issuing voter-approved unlimited  
10          tax general obligation bonds to finance the 30,000-square-foot Redmond Library located  
11          at the corner of NE 85th and 160th streets in 1999, and

12          WHEREAS, while the area bonds were paid off in December 2017, there is a  
13          balance in the debt service fund that must be managed by the members of the area  
14          governing body, and

15          WHEREAS, there are three vacancies on the area governing body, and

16          WHEREAS, RCW 27.15.030 requires that the area have a governing body  
17          consisting of three members of the county legislative authority to be appointed by a  
18          majority of the full county legislative authority, and

19          WHEREAS, the provision of library services to the area is provided by the King

20 County Library System, and

21 WHEREAS, the King County Library System has requested that the county  
22 appoint members to the governing body for the purpose of reallocating the funds and  
23 dissolving, and

24 WHEREAS, under RCW 27.15.060(1), the area may be dissolved by a majority  
25 vote of the governing body;

26 NOW, THEREFORE BE IT MOVED by the Council of King County:

- 27           The members of the Redmond Library Capital Area governing body shall be:  
28           A. Claudia Balducci, chair;  
29           B. Reagan Dunn; and  
30           C. Kathy Lambert.
