1 A MOTION to extend the interim appointment of James J.
2 Buck as the director of the records, elections and licensing
3 services division of the department of executive services
4 for a sixty-day period.

7 WHEREAS, on July 17, 2006, James J. Buck was appointed as the interim
8 director of the records, elections and licensing services division ("REALS") of the
9 department of executive services pursuant to K.C.C. 2.16.110 E.1, and

10 WHEREAS, an offer of employment for REALS director was offered to a
11 candidate in August 2006 and negotiations ensued into September, ultimately resulting in
12 nonacceptance by the candidate, and

13 WHEREAS, the primary election occurred on September 19, 2006, and

14 WHEREAS, King County elections made preparations for the November 7
15 general election immediately following certification of the primary election, and

16 WHEREAS, elections officials throughout the nation prepared and administered
17 the November general election in the months of October and November 2006, and

18 WHEREAS, the availability or ability of candidates with the requisite skills and
19 experience to be the REALS director during this time period is virtually nonexistent, and

20 WHEREAS, the executive and the department of executive services hereby
21 certify that they are currently engaged in a competitive search process for the position,
22 and

23 WHEREAS, King County has contracted with the Waldron Company to provide
24 recruitment services for the REALS director position, and

25 WHEREAS, the continuity of leadership in King County elections is a necessary
26 ingredient in preparing and administering successful elections, during the pendency of
27 recruitment efforts, and

28 WHEREAS, it is in the best interest of the county and its citizens and is critical to
29 the effective running of the records, elections and licensing services division that Mr.
30 Buck continue serving in the interim while the search for qualified candidates for the
31 position has been concluded, and

32 WHEREAS, the initial appointment of James J. Buck as the interim director is
33 limited to one hundred fifty days pursuant to K.C.C. 2.16.110 E.1, and

34 WHEREAS, the one-hundred-fifty-day maximum initial appointment duration
35 will expire after December 13, 2006, and

36 WHEREAS, pursuant to K.C.C. 2.16.110 E.1, the county council shall grant at
37 least one successive sixty-day extension of the interim appointment;

38 NOW, THEREFORE, BE IT MOVED by the Council of King County:

Motion 12425

39 James J. Buck shall continue to serve as the interim director for the records,
40 elections and licensing services division of the department of executive services for an
41 additional sixty days while the search for, and placement of, a new director is completed.

County Council on 12/11/2006, by the following vote:


