ORDINANCE 18671

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, February 26, 2018, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0037 (Ordinance 18671) an ordinance relating to the County's zoning code. The Council then adopted this Ordinance at their Monday, March 5, 2018 meeting.

SUMMARY:

Ordinance 18671 amends the King County Zoning Code to add a new use, "regional transit authority facility" and permit that new use within the low density urban residential zones. This use is exempt from height and setback requirements.
