Honorable Councilmembers,

We are writing you today regarding the proposed re-route of the 271, which connects Issaquah to Bellevue College, Bellevue Transit Center, and the University of Washington. The re-route of the 271 will have a negative impact on Bellevue College students, staff, and faculty. The proposed cut would eliminate the bustop on campus, which serves 900+ rides a day. This route is a key piece of Bellevue College's accessibility and convenience. Being the only bus between Bellevue Transit Center and Bellevue College, re-routing the 271 would remove student's access to campus from Bellevue, further separate them from an important hub for public transportation on the Eastside, and prevent easy access to students enrolled at BC and UW.

The effect of the proposed re-route is considerable and negative. Buses dropping and picking up over 900 riders a day on 148th Ave SE instead of campus would add congestion to an already congested street. The distance to the campus presents issues for safety and accessibility. At night the walk is dark and does not feel safe for most of our students. These changes impact equitable access to campus as the distance needed to be travelled would make the campus difficult to access for students with disabilities.

The current stop is on campus and features a heated shelter with bus arrival screens and a bike repair station. This creates a welcoming environment that promotes using buses and other means of alternative transit. These amenities have proven to make our campus accessible.

Access to education is essential for upward mobility in our society. Many people who use the bus have no other transportation options. By re-routing the 271, you are making Bellevue College less accessible. The outcome will be a flood of students to the already congested 148th Ave, wearing down roads, lengthening commute times, and affecting the college's enrollment. Keeping 900+ riders out of cars and on the 271 is important for educational access, important for the Bellevue community, and important for the environment.

The Associated Student Government of Bellevue College strongly advises the King County Council to recommend maintaining the 271's current route on campus.
