Mr. Phillips reported on the Woodland Park Zoological Society. The Board discussed reconstruction to the west entry and the penguin exhibit, adjacent to the west entry.

Mr. Dunn reported on the Cedar River Council and the issue of the Knotweed species, a very invasive plant spreading on the Cedar River.

Mr. Constantine briefed the Council on the Sound Transit Operations Task Force. The members discussed cost saving options for operations and much needed base capacity increases for Sound Transit's bus fleet. Staff presented several options for restructuring the way Sound Transit provides service in order to significantly reduce expenses.

Ms. Patterson reported on the Puget Sound Regional Council Executive Board. The Board approved

all the transportation committee work recommendations, and certified the 2006-2007 comp plan amendments for the City of Burien. The Board also approved additional PSRC federal funds for contingency list projects.

Ms. Patterson briefed the Council on Sound Transit. The Board received a briefing on the final outcome of the public outreach regarding going back to the ballot on Sound Transit Phase II. Ms. Patterson indicated that Greg Nickels, Chair of Sound Transit, put forth a Sound Transit Phase II twelve year funding plan for review. The Board will continue discussion and will be making a decision on July 24.
