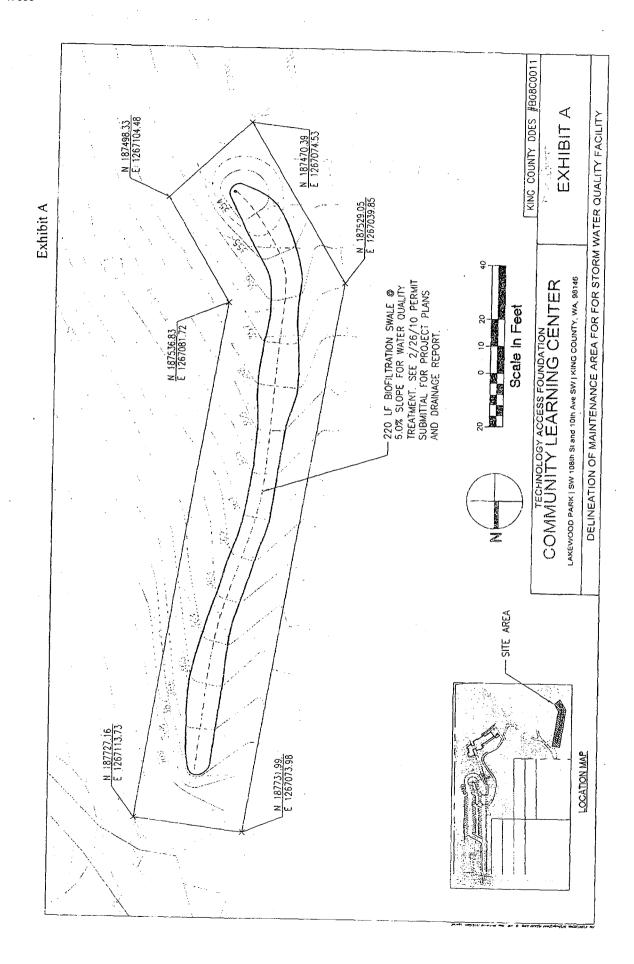

Commencing at the Southwest corner of the East half of the Northeast quarter of the Northwest quarter of said Section 7; Thence, North 010-27'-00" East along the west line of said East half of the Northeast quarter of the Northwest quarter 1180.81 feet to the True Point of Beginning; Thence, continuing North 01°-27'-00" East 150.00 feet to the South line of said Section 6; Thence, North 890-317-16" East along the South line of said Section 6, 30.00 feet, more or less, to the East line of 10th Avenue Southwest; Thence, North 01°-18'-07" West along said East line 811.50 feet; Thence, North 89°-44'-43" East 151.50 feet; Thence, North 1°-18'-07" West 240.00 feet; Thence, South 890-44'-43" West 28.50 feet; Thence, North 10-18'-07" West 58.50 feet; Thence, North 890-44'-43" East 230.00 feet; Thence, North 10-18'-07" West 181,50 feet to the South line of Southwest 108th Street; Thence, North 890-441-43" East along the said South line 245.90 feet to the West line of 8th Avenue Southwest (formerly Burien Way); Thence, along said West line, South 010-371-52" East 105.06 feet to a tangent curve to the left having a radius of 603.14 feet; Thence, along said curve through a central angle of 180-08'-50" a distance of 191.03 feet; Thence, South 010-374-52" East 338.15 feet; Thence, North 890-411-57" East 398.43 feet; Thence, North 00-54'-25" West 329.86 feet; Thence, North 890-44'-45" East 122.00 feet; Thence, North 00-54'-25" West 299.76 feet to the South line of Southwest 108th Street; Thence, North 890-471-02" East along said South line, 14.63 feet to a tangent curve to the left having a radius of 455.14 feet; Thence, along said curve through a central angle of 230-24'-42" a distance of 185.98 feet to a curve to the right having a radius of 395.14 feet; Thence, along said curve through a central angle of 10-57'-06" a distance of 13.46 feet; Thence, South 000-18'-00" East 1072.32 feet; Thence, South 820-11'-20" Wast 185.85 feet; Thence, South 070-49'-01" East 390.67 feet; Thence, South 890-46'-22" West 1243.21 feet to the True point of Beginning. EXCEPT portion lying within SW 108th Street., which was conveyed to King County for road purposes by deed recorded in Volume 8 of Road Books, page 294, under Auditor's File No. 144401. Containing 34.2737 acres, more or less. SUBJECT to an easement for the purpose of constructing and maintaining a 24-inch sewer time; SUBJECT ALSO to easements for the purpose of constructing and maintaining power lines and pole lines; SUBJECT ALSO to the rights of the public in and to that portion of a road at the North end of the land above described, where the North and South center line of the Southwest quarter of the Southeast quarter of section 6 intersects the North boundary of the above described property.
