1	A MOTION relating to the review process for the 2008
2	King County Comprehensive Plan update.
3	
4	WHEREAS, historically, the approach taken for the review of major updates to
5	the King County Comprehensive Plan has been to utilize other standing committees to
6	perform panel reviews of specific chapters and issues and to make recommendations to
7	the growth management and natural resources committee ("the committee"), and
8	WHEREAS, that practice ensured that those committees with the staff expertise in
9	specific subject areas were utilized in the review of the update and report staff findings to
10	those other standing committees, and
11	WHEREAS, as a result of this approach, the ability of the committee to
12	coordinate changes to often interrelated policies across the various chapters was
13	impaired, and
14	WHEREAS, because review of the draft proposed Comprehensive Plan update
15	indicates much more interconnectedness of policies than in the past Comprehensive
16	Plans, the ability to follow the linkages and ensure internal consistency will be
17	increasingly important, and

18	WHEREAS, the Comprehensive Plan update manager is a newly created position
19	and provides a unique opportunity to utilize a more effective and unified approach to the
20	review of the 2008 Comprehensive Plan update, and
21	WHEREAS, all council members, for the purposes of reviewing the
22	Comprehensive Plan are voting members of the committee, and
23	WHEREAS, to underscore the broad policy impacts that the Comprehensive Plan
24	has on all facets of county business and to centralize all aspects of the Comprehensive
25	Plan review in the committee to ensure a complete and coordinated review of the
26	interrelated policies the committee should manage all aspects of the review (e.g.
27	coordinating the reviews, managing the schedule and applicable policy staff, handling the
28	day-to-day issues, and presentation of staff reports) of the Comprehensive Plan, and
29	WHEREAS, this would require central staff with the historical knowledge and
30	specific expertise in the various areas covered by the Comprehensive Plan to perform
31	reviews and report such findings directly to the committee, rather than the standing
32	committee to which they are assigned, and
33	WHEREAS, to foster an efficient review of the Comprehensive Plan, committee
34	leadership should seek to identify consensus issues, thereby allowing the committee to
35	focus on matters that need further discussion;
36	NOW, THEREFORE, BE IT MOVED by the Council of King County:
37	A. The growth management and natural resources committee shall perform all
38	council committee review of the 2008 update of the King County Comprehensive Plan;
39	and

B. The growth management and natural resources committee shall utilize policy staff from other standing committees based on their specific areas of expertise to perform the review of the 2008 revisions to the Comprehensive Plan. The chair of the growth management and natural resources committee shall consult with the applicable standing committee chair and policy staff director, and assign policy staff from standing committees for Comprehensive Plan review.
