NOTICE IS HEREBY GIVEN that a notice of intention has been filed with the King County Council relating to the annexation of approximately 120 acres of land into the Sammamish Plateau water and sewer district, known as the Siler Ridge Water Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001, on Tuesday, December 6, 2022, at 1:00 p.m.; remote public testimony on Zoom will be accepted.
