

PROPOSED ORDINANCE 2016-0156
Best Starts for Kids | Youth and Family Homeless Prevention Initiative

Cross Reference to RED-LINE Version of Attachment A to Striking Amendment S2
Updated May 3, 2016

The Best Starts for Kids Levy includes a \$19 million Youth and Family Homeless Prevention Initiative. Per the levy ordinance, an implementation plan for this initiative was transmitted to Council on March 1, 2016 (Proposed Ordinance 2016-0156).

The matrix below outlines changes to the proposed implementation plan as part of a Striking Amendment S2. This matrix lists ONLY the changes that are newly added after Striking Amendment S1 that was discussed at HHHS on April 27.

This matrix is based on the RED-LINE version of Attachment A to S2, dated May 3, 2016. Please note that any amendments drafted to this striker will be drafted to the CLEAN version of S2, per legislative protocol.
