Good day,

I would like to submit public comment on the vacation of the park entrance at 43rd Ave S. While I'm not familiar with the specifics of the proposal, I presume the intent is to eliminate the area which attracts people who do not practice the behaviors of upstanding citizenry. This is exhibited by the debris and garbage, loitering in cars after dark, and the New Years and Independence Day firework displays which threaten to rattle the fillings out of my teeth. I hope the intent is not simply for the adjoining property owners to get a larger yard at the expense of the rest of the community's park access.

However, I would also like to comment that the park access is a valuable community resource, used extensively by neighborhood residents for exercise and dog walking. My family as well as others use the entrance daily during the school year to commute to Camelot Elementary, which is designated as a walking school. The school does not have school bus service, and believe you me, they don't need another few cars trying to get through that parking lot every morning. The park entrance also provides access to the bus line on 294th St. from the opposite side of the neighborhood. While there is another park entrance about two blocks to the east, that access is commonly flooded during the winter and so is difficult to use.

I hope that some solution can be reached which will satisfy most community members, such as blocking the parking area with boulders, or maintaining a narrow trail access to the park while the adjacent property owners acquire most of the area.
