Dear Councilmember McDermott:

Enclosed for consideration and approval by the King County Council are individual motions confirming the board appointments to the new King County Priority Hire Advisory Committee.

The King County Priority Hire Advisory Committee was established by King County Ordinance 18672. The Ordinance states: “The manager shall establish a priority hire advisory committee, consisting of eight to twelve members, to be appointed by the executive and confirmed by the council.” And, “The committee shall operate in an advisory role to the county for implementation and effectiveness of this chapter. The committee shall advise the division on planning, input prior to the development of the master community workforce agreement, administration and reporting. The committee shall consult with King County’s immigrant and refugee commission, women’s advisory board and communities of opportunity best starts for kids advisory board to identify ways to recruit and retain people in apprenticeships who have historically not been involved in the construction trades or who are from economically disadvantaged communities or are immigrants and refugees. In addition, the committee shall advise the division on the program’s performance in serving economically disadvantaged communities and the program’s impacts on women-owned or minority-owned businesses, open shop contractors and small contractors and suppliers, and shall make recommendations, as necessary, to the division to make adjustments to the program to maximize its responsiveness to these communities.”
