NOTICE IS HEREBY GIVEN that a Notice of Intention has been filed with the King County Council relating to the annexation of approximately 99.98 acres of land into the King County water district No. 119, known as the Felling Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council is to be held in Room 1001, King County Courthouse, on Tuesday, May 29, 2018 at 1:30 p.m.

A description of the proposed area to be annexed is as follows:

A portion Section 16 and 21 ship 26 North, Range 7 East of the Willamette Meridian, King County, Washington; more particularly described as follows:

The South Half of the Southwest Quarter of the Southeast Quarter of Section 16, Township 26 North, Range 7 East of the Willamette Meridian, together with the South Half of the Northwest Quarter and the Southwest Quarter of the Northeast Quarter of Section 2, Township 26 North, Range 7 East of the Willamette Meridian, King County, Washington.
