A notice of intention proposing the annexation of approximately 7 9 acres of land into the Woodinville Water District, known as the Goldberg 10 Annexation, for the purpose of extending water service was filed with the county council on July 6, 2007. 11 12 2. Woodinville Water District has found the petition for transfer to be 13 sufficient and has concurred with the proposed transfer in Resolution No.
