Dear Brian:

In accordance with your request and authorization, Aviation Management Consulting Group (AMCG) has prepared an *Airport Fee Study Update* for the Boeing Field/King County International Airport (Airport) for your review and consideration. The aeronautical-related fees researched include fuel flowage fees, transient aircraft fees, landing/departure fees, based aircraft fees, transient parking fees, percentage of gross receipts fees, aeronautical permit fees, and airport access fees. In addition, AMCG researched administrative fees including construction permit fees, vehicle parking fees, filming fees, late fees/interest charges, lease assignment fees, and staff hourly rates.

Based on the aeronautical fees analyzed from comparable airports, airports with aircraft final assembly plants, competitive airports, and airports identified by the lease framework working group, AMCG provided a recommendation for how such fees should be updated (as necessary) to the Aeronautical Fee Schedule (Table 11 of the 2022 *Airport Fee Study*).

### I. SIGNIFICANT FINDINGS

Consistent with the project approach as stated in the Proposal (dated January 27, 2025) and *Preliminary List of Airports* (dated January 31, 2025), aeronautical and administrative related fees at comparable airports, airports with aircraft final assembly plants, competitive airports, and lease framework working group airports were analyzed.

### A. Comparable Airports

The selection of comparable airports was based on historical reported activity levels, total reported based aircraft, the presence of a control tower and precision instrument approach, runway length, total airport acreage, Federal Aviation Administration (FAA) National Plan of Integrated Airport Systems (NPIAS) classification, and FAA General Aviation Airport Asset Study classification. Parameters were then established in each of these areas to facilitate the selection process. In addition, Centennial Airport, Teterboro Airport, and Van Nuys have been included due to the similar markets served within a metropolitan area.

Based on the criteria and parameters identified, AMCG developed a preliminary list of 14 airports which, in the opinion of AMCG, are considered comparable to the Airport, as follows:

### Significant findings follow:

- Fuel Flowage Fees
  - 1 of the 12 airports charges a fuel flowage fee of \$0.18 per gallon for commercial operators and \$0.29 per gallon for non-commercial operators regardless of fuel type
- Landing Fees
  - 8 airports charge a landing fee based on MGLW ranging from \$1.00 to \$3.68 per 1,000 MGLW
- Departure Fees
  - 1 airport charges a departure fee as follows:
    - less than 6,000 lbs. MGLW \$21.25
    - 6,000 lbs. to 12,499 lbs. MGLW \$31.25
    - 12,5000 to 79,999 lbs. \$44.38 per 1,000 pounds of MGLW
    - 80,000 lbs. or more \$8.15 per 1,000 MGLW is charged.
- Transient Parking Fees
  - 4 of the 9 airports charge a daily aircraft parking fee ranging from \$5.00 to \$150.00 per day (a mean of \$41.42 per day)
  - 1 airport charges an aircraft parking fee of \$1.29 per 1,000 MGLW
  - o 1 airport charges aircraft parking fees based on weight (pounds) as follows:
    - 6,500 and under \$15
    - **6**,501 10,500 \$20
    - **1**0,501 12,500 \$25

  - 10 airports charge an Airport Access Fee

  - 1 airport charges an Airport Access Fee for non-tenants of \$43.00
  - 8 airports charge airport access fees ranging from \$20.00 to 75.00 (mean of \$33.75)
- > Filming Fees
  - Dependent on crew size (typically maxing out at \$2,000)



### B. Airports with Aircraft Final Assembly Plants Airports

The Airport accommodates final preparation of certain Boeing Company aircraft prior to delivery. Due to the unique nature of this activity, 11 airports within the United States which accommodate aircraft final assembly plants have been included in the analysis as well.

### Fuel Flowage Fees

 1 of 8 airports charges fuel flowage fee specifically for non-commercial self-fueling of \$0.17 per gallon for Jet A.

### Landing Fees

 3 airports charge landing fees based on MGLW ranging from \$3.06 to \$4.90 per 1,00 pounds MGLW

### Departure Fee

 1 airport charges a departure fee of \$2.00 per 1,000 pounds for aircraft over 5,000 pounds MGLW

### Transient Parking Fees

- 3 airports charge daily aircraft parking fees ranging from \$8.00 to \$350.00 per day (mean of \$183.78 per day)
- 1 airport charges a parking fee based on aircraft weight as follows:
  - 12,499 and under \$18.02
  - **12,500 49,999 \$76.32**
  - **5**0,000 99,999 152.64
  - **1**00,000+ \$312.70
- 1 airport charges a monthly aircraft parking fee of \$140.00

### > Filming Fees

 1 airports charges filming fees with amount being dependent on hours needed at the airport



### C. Competitive Airports

Typically, an airport is considered competitive if located in proximity to the airport and serves a similar market. Each airport identified is then compared to the Airport based on (1) infrastructure and (2) available products, services, and facilities.

For the purposes of this study, 7 airports within 45 nautical miles of the Airport were identified as being potentially competitive airports.

It is significant to note Renton Municipal Airport and Snohomish County Airport (Paine Field) were identified as an Airports with Aircraft Final Assembly Plants and a competitive airport. Fees and related information from these airports will be included in both sets of data which is reflective of the similar use and relative proximity of to the subject airport.

### Landing Fees

 3 airports charge landing fees based on MGLW ranging from \$1.50 to \$4.90 per 1,000 pounds MGLW

### Departure Fee

 1 airport charges a departure fee of \$2.00 per 1,000 lbs. for aircraft over 5,000 pounds MGLW

### Aeronautical Permit Fee

 1 airport charges an annual license fee of \$1,000 for aircraft fueling operators

### Transient Parking Fees

- 3 airports charge daily aircraft parking fees ranging from \$3.00 to \$500.00 per day (a mean of \$113.00 per day)
- 3 airports charge a monthly aircraft parking fee ranging from \$40.00 to \$61.76 a month

### Significant findings follow:

- Landing Fees
  - 3 airports charge landing fees based on MGLW ranging from \$1.15 to \$4.90 per 1,000 pounds MGLW
- Departure Fee
  - 1 airport charges a departure fee of \$2.00 per 1,000 lbs. for aircraft over 5,000 pounds MGLW
- Transient Parking Fees
  - 4 airports charge a daily aircraft parking fee ranging from \$8.00 to \$350.00 per day (mean of \$73.36 per day)
  - 3 airports charge a monthly aircraft parking fee ranging from \$35.00 a month to \$85.92 (mean of \$64.36)
  - 1 airport charges a daily aircraft parking fees as follows:
    - Single-Engine \$12
    - Twin \$25
    - Small Jet \$50
- > Percentage of Gross Receipts Fee
  - 1 airport charges a percentage of gross receipts fee of 10% for rental car operations
- Aeronautical Permit Fees
  - 1 airport charges a Skydiving annual permit fee of \$14,627
- Vehicle Parking Fee
  - o 1 airport charges a vehicle parking of \$18.00 a day
  - 1 airport charges a monthly vehicle parking fee as follows:
    - Up to 25 feet \$46.73 (temporary)
    - 25 feet and greater \$63.07 (temporary)
    - Up to 25 feet \$467.21 (long term)
    - 25 feet and greater \$594.89 (long term)



### II. AERONAUTICAL FEE SCHEDULE

AMCG recommends the County establish and implement the following Aeronautical Fee Schedule for the Airport to help recover the costs being incurred by the County relating to the planning, development, operation (including maintenance and repair), management, and marketing of the Airport (that are not covered by federal or state AIP funds).
