1           A MOTION authorizing the chair of the council to enter  
2           into a contract for an independent consultant to assist in a  
3           performance audit of the facilities management division's  
4           planning and budgeting for capital facilities construction  
5           projects; the audit will evaluate how effectively the  
6           facilities management division plans and budgets for  
7           capital facilities construction projects and whether its  
8           policies, procedures and practices are consistent with  
9           industry best practices and standards.

11           WHEREAS, the county's procurement services office issued a request for  
12           proposals ("RFP") to assist the auditor's office in performing the performance audit of the  
13           King County facilities management division's planning and budgeting for capital  
14           facilities construction projects, and

15           WHEREAS, an RFP evaluation committee, comprised of county auditor staff, the  
16           executive's internal audit manager and the director of the city of Seattle's fleets and  
17           facilities department, evaluated the proposals, conducted interviews and determined that

18 the proposal from Cedar River Group LLC best meets the selection criteria outlined in the  
19 RFP, and

20 WHEREAS, the county auditor also evaluated the consultants' proposals and  
21 references, spoke with Cedar River Group LLC, and determined that Cedar River Group  
22 LLC has the qualifications and expertise to evaluate facilities management division's  
23 capital planning and budgeting, and

24 WHEREAS, Motion 10651, Section III, as amended, and OR 1-020 requires the  
25 council to authorize the council chair to sign any contracts in excess of twenty-five  
26 thousand dollars in the legislative branch;

27 NOW, THEREFORE, BE IT MOVED by the Council of King County:

28 The chair of the metropolitan King County council is authorized to enter into a  
29 contract, in an amount not to exceed one hundred thousand dollars with Cedar River


