12 Washington, has requested the authority from the King County council to cancel the
13 taxes;

14 NOW, THEREFORE, BE IT MOVED by the Council of King County:

15 The manager of treasury operations of King County is hereby authorized to cancel
16 the tax billings in the amount of \$1,408,143.41, as indicated in Attachments A, B and C

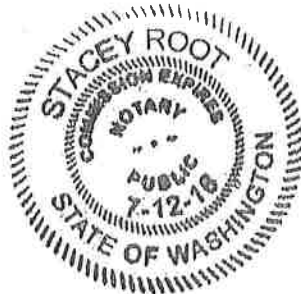
