WHEREAS, K.C.C. chapter 20.18 limits consideration of substantive changes to the Comprehensive Plan, including changes to the urban growth boundary, to every fourth year beginning in 2000. K.C.C. 20.18.030C allows for the consideration of substantive changes on even calendar years if the county determines by motion that the purposes of the Comprehensive Plan are not being achieved as evidenced by official population growth forecasts, benchmarks, trends and other relevant data, and

WHEREAS, the Snoqualmie Urban Growth Area Subarea Plan 2001, adopted on June 4, 2001, by Ordinance 14117, includes an up to date population capacity estimate for the city of Snoqualmie and its urban growth area, documents that amendment of the city of Snoqualmie's urban growth area is warranted to ensure sufficient capacity exists to
