3 On page 1, beginning on line 10, strike everything through page 2, line 18, and insert:

4 "BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

5 **SECTION 1. Findings:**

6 A. King County has reached agreement regarding compensation with the
7 Washington State Council of County and City Employees, Council 2, Local 2084-SC
8 (Superior Court - Family Court Operations; Court Appointed Special Advocates
9 Specialists and Attorneys (CASA)) representing employees in the King County superior
10 court, effective January 1, 2017.

11 B. It is necessary to approve and adopt this agreement so that it can be
12 implemented before the end of the calendar year to avoid tax and benefit implications for
13 members of the bargaining unit.

14 **SECTION 2.** The memorandum of agreement regarding a compensation
15 agreement negotiated by and between King County and Washington State Council of
16 County and City Employees, Council 2, Local 2084-SC (Superior Court - Family Court
17 Operations; Court Appointed Special Advocates Specialists and Attorneys (CASA))
18 representing employees in the King County superior court, which is Attachment A to this

19 ordinance, is hereby approved and adopted by this reference made a part hereof.

20 SECTION 3. Terms and conditions of said agreement shall be effective January
21 1, 2017.

22 SECTION 4. The county council finds as a fact and declares that an emergency
23 exists and that this ordinance is necessary to be implemented prior to the end of the calendar
24 year to avoid potentially serious negative tax and benefit implications for members of the
25 bargaining unit that would be avoided with the timely adoption of this ordinance."

26 **EFFECT:** *Adds emergency findings and emergency clause to the ordinance so that it*
27 *will take effect immediately, so as to avoid tax and benefit implications to members of*
28 *the bargaining unit, which could occur if implementation does not happen during the*
29 *2017 calendar year.*

3 "AN ORDINANCE approving and adopting the
4 memorandum of agreement regarding a compensation
5 agreement negotiated by and between King County and
6 Washington State Council of County and City Employees,
7 Council 2, Local 2084-SC (Superior Court - Family Court
8 Operations; Court Appointed Special Advocates Specialists
9 and Attorneys (CASA)) representing employees in the
10 King County superior court; establishing the effective date
11 of said agreement; and declaring an emergency."

12 **EFFECT: *Adds an emergency clause to the title of the ordinance so that it will take***
13 ***effect immediately.***
