Findings:** 8 9 1. The city of Auburn, Washington, by Amended Resolution 3497 has 10 determined that it is in the public interest and general welfare to provide for the 11 annexation of an area known as the Totem District, in accordance with chapter 35A.14 12 RCW. 13 2. City of Auburn Amended Resolution 3497 satisfies the provisions of chapter 35A.14 RCW for qualification for annexation. 14 15 3. The city of Auburn, by Amended Resolution 3497, initiated the annexation of 16 the Totem area.

17	4. The King County boundary review board received a request for review under
18	chapter 36.93 RCW, and on August 23, 2002, the review board, in file 2126, deemed the
19	proposed city of Auburn Totem annexation file approved.
20	5. Pursuant to chapters 29.13 and 35A.14 RCW, the metropolitan King County
21	council deems an emergency exists for the purpose of calling a special election to be held
22	on the question of this annexation on November 5, 2002.
23	SECTION 2. A special election shall be held on the 5th day of November 2002 in
24	accordance with chapter 35A.14 RCW within the territory of the proposed annexation,
25	for the purpose of submitting the question of annexation of the Totem annexation area.
26	SECTION 3. The number of registered voters within the subject area is estimated
27	at seventy-four as nearly as may be determined from available records.
28	SECTION 4. The King County manager of the records, elections and licensing
29	services division is hereby requested to assume jurisdiction to call and conduct a special
30	election and submit to the registered voters within the subject area the proposition as set
31	forth in section 4 of this ordinance. The clerk of the council is hereby authorized and
32	directed to transmit said proposition to the manager of records and elections in
33	substantially the following form, with such additions, deletions or modifications in the
34	ballot title as may be required for the proposition listed below by the King County
35	prosecutor:

AMENDED RESOLUTION NO. 3497

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AUBURN, WASHINGTON, REQUESTING THAT THE ANNEXATION OF AN UNINCORPORATED AREA CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY BE PLACED BEFORE THE VOTERS OF THE PROPOSED ANNEXATION AREA - SOUTH OF 29TH STREET SE AND WEST OF D STREET SE KNOWN AS THE "TOTEM DISTRICT"

WHEREAS, the City of Auburn has received requests that certain areas of unincorporated territory contiguous to the corporate limits of the City, which unincorporated territory is identified for reference as South of 29th Street SE and West of D Street SE known as the "TOTEM DISTRICT" Annexation area; and,

WHEREAS, the City is authorized to initiate annexations via election pursuant to RCW 35A.14.015; and,

WHEREAS, when the Auburn City Council determines that the best interests and general welfare of the City would be served by the annexation of the unincorporated territory contiguous to such city, it would thusly be appropriate to call for an election to be held to submit to the voters of such territory the proposal for annexation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AUBURN, WASHINGTON, HEREBY RESOLVES as follows:

Section 1. That the Auburn City Council has determined that the best interests and general welfare of the City would be served by the annexation of the unincorporated territory contiguous to such city, and that it is appropriate to call for an election to be held to submit to the voters of such territory the proposal for annexation.

Section 2. That the description of the boundaries of the area to be annexed, located

SITUATE IN KING COUNTY, WASHINGTON.

Section 3. That the number of voters residing therein as nearly as may be determined is seventy-four (74).

Section 4. That the City shall pay the cost of the annexation election.

<u>Section 5</u>. That upon annexation, the territory so annexed shall be subject to proposed zoning regulation for the area to be annexed as R-2, Single Family Residential District.

Section 6. That, in light of the small size of the annexation area (approximately 18 acres), pursuant to RCW 35A.14.220, it is requested that the King County Boundary Review Board waive or decline review.

Section 7. That a certified copy of the resolution shall be filed with the legislative authority for King County, and with the King County Boundary Review Board.

<u>Section 8</u>. That the Mayor is authorized to implement such administrative procedures as may be necessary to carry out the directives of this legislation, including providing notices pursuant to RCW 35A.14.070, and filing a Notice of Intent to Annex to the King County Boundary Review Board, and communicate the City's request that the King County Boundary Review Board waive or decline review. The Mayor, or designee, is further authorized to take such other steps as is reasonably necessary to have the annexation placed on the ballot before the appropriate voters for the November 5, 2002 election.

Section 9. That this Resolution replaces and supercedes the Resolution of the
