Ms. Patterson reported on the Puget Sound Regional Council Executive Board. The Board discussed the criteria to select transportation projects. The Board is reviewing projects that encompass transit, roads and pedestrian projects across the four counties. The Board is also developing a strategy for the four counties that set very clear criteria to meet the economic goals of the plan. The Board will select the projects that will receive federal funding this July.

Mr. Constantine reported on the Sound Transit Board meeting. The Board discussed renaming the Sound Transit Board meeting room in honor of the late Ruth Fisher to the Ruth Fisher Sound Transit Board Room. Mr. Constantine remembered fondly how Representative Fisher referred to herself as the mother of regional transit and the mother of Sound Transit. He credits her for the region being on the verge of the new transit era. Mr. Constantine reminisced that Rep. Fisher was a tremendous character, an independent and creative thinker who often spoke her mind. Mr. Constantine expressed his hope that her legacy will live on forever.
